We will be using computers that are running Microsoft Windows XP Professional (Windows). Windows is often referred to as a WYSIWYG OS ... What You See Is What You Get Operating System.

Just remember, if you fail to write something down, that's no guarantee that it won't be on a test.

3. Not all keyboard shortcuts will work in all programs.

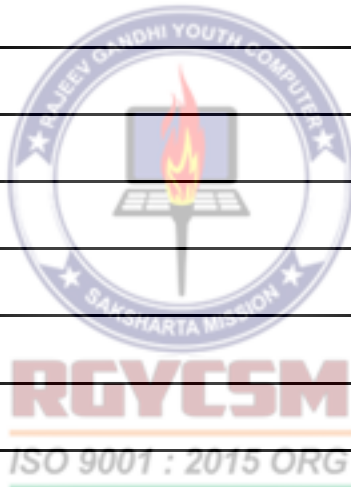

Class Notes

1. Each student will be responsible for supplying their own pens or pencils and extra note paper.
2. The text used is “**easy Windows XP Professional**”, by Que Publishing. There is also a Fold out called **PC Basics**, by Quamut. While not mandatory, a book will aid in the learning process. If desired, the Instructor will order and pick up both "books" for a 20% discount at Barnes and Noble. There is also a Class Workbook available for free in electronic format. See the last page for typical prices if you wish to purchase any of the books
3. The Chapters listed next to each lesson are those recommended for reading prior to the start of that class. “Workbook” indicates that some of the material presented will not be from the book. Not all chapters in the book will be required reading but it is highly recommended that students read them anyway, preferably while sitting at an operating computer so they may see the examples given.
4. Combined lecture and lab sessions will total 2.5 hours per session. Presentation of a Certificate of Completion depends upon at least 80% attendance, good quiz scores, and a passing Final Exam grade. The final exam is open-book, open-note so good notes are important.
5. Students need to practice outside of the classroom to help them gain the additional skills they need. The Lab computers should be available during the day and/or weekends when other classes are not in session. Most Maryland Libraries also have public use computers available.
6. It is the instructor’s job (and desire) to teach and therefore the material must be easy to understand. It is the student’s job to ensure they get the required material. If you have any questions during the lecture, please ask ... there will be others, not nearly as brave, who will appreciate your intervention. If the student is having trouble understanding the material, they should arrange for extra tutoring, either with other current or prior students or the instructor.
7. The instructor will do his best to stay on-track with the syllabus but will also try not to discourage spirited classroom discussions that pertain to learning anything important having to do with basic computer operation. If a student has an immediate need for certain information, ask. If the question cannot easily be worked into the course material it can be answered after class.
8. There will be required quizzes during the course given on an irregular schedule. They should be expected about every other classroom session. The quizzes are designed to assist the instructor in determining how well he is doing with the presentation of the material. All quizzes are open book, open notes, so well thought out and legible notes will help you do well on the quizzes. All quizzes and the final must be taken and a Certificate of Completion will not be issued if one is missing.
9. Students should do their best to arrive on time for the eighth class and may want to dress up a little as the instructor will bring a Digital Camera to class to demonstrate Digital Photography by taking class pictures. Random pictures will be taken during the course for inclusion on the class CD.
10. Students will have to use non-classroom computers already connected to the Internet to explore the Internet and learn how to browse and search as the classroom does not currently have an Internet connection.
11. All examples and student created databases, documents, and spreadsheets will fit on a Floppy or RAM disk if students wish to keep their own creations. All demo files will be available upon graduation on the student CD.

Rules for Fighting Fires

Fires can be very dangerous. You should always be sure that you would not place yourself or anyone else at risk if you decide to try and extinguish a fire. These rules will help you make a safe decision if you discover a fire at home or your workplace.

- A. Assist any person in immediate danger, to get to safety, if it can be accomplished **without risk to yourself**.
- B. Call the Fire brigade by dialing 000 (Australia) or 911 (United States), and activate the building fire alarm system (or designating someone else to do this for you).
- C. Ensure people in the building are aware of the emergency and are starting to move out.
- D. Only after having done these three things, and if the fire is **small**, should you attempt to use an extinguisher to put it out.

If you decide to fight the fire, keep these rules in mind:

ALWAYS

- ✓ **Operate the extinguisher briefly as you approach the fire**, to ensure that it working properly. (With dry chemical powder type extinguishers it is possible that when initially operated, the powder may not allow the valve to fully close again, therefore you should be approaching the fire when you test the extinguisher.)
- ✓ Obtain assistance if possible before you fight the fire.
- ✓ Make sure that there is a clear escape path behind you.

NEVER ATTEMPT TO FIGHT A FIRE IF:

- ⊘ **You don't know what is burning.** If you don't know what is burning, you don't know what type of extinguisher to use or what other hazards to expect. There may be something burning that will explode or perhaps produce toxic fumes. Unless you know what is on fire then let the fire brigade handle it when they arrive.
- ⊘ **The fire has started to spread rapidly.** A portable extinguisher is only useful for small fires. If the fire is already spreading quickly, it is best to simply close the doors and windows to slow down the spread of the fire and evacuate the building.

Do Not Fight the Fire If:

- ✗ **You don't have adequate or appropriate equipment.** If you don't have the correct type or large enough extinguisher, it is best not to try to fight the fire. (Always test the extinguisher to ensure it is serviceable before you go near to the fire)
- ✗ **You might inhale toxic smoke.** If the fire is producing large amounts of smoke that you would have to breathe in order to fight it, it is best not to try. Any sort of combustion will produce some amount of carbon monoxide, but when synthetic materials such as the nylon in carpeting or foam padding in a sofa burn, they can produce highly toxic gases such as hydrogen cyanide, acrolein, and ammonia in addition to carbon monoxide. These gases can be fatal in very small amounts.
- ✗ **Your instincts tell you not to.** If you are uncomfortable with the situation for any reason, just let the fire department do their job.

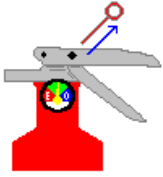
The final rule is to always position yourself with an exit or means of escape at your back before you attempt to use an extinguisher to put out a fire. In case anything unexpected happens, you need to be able to get out quickly, and you don't want to become trapped. Just remember, always keep an exit at your back.

How to Operate an Extinguisher

PASS

It's easy to remember how to use a fire extinguisher if you can remember the acronym **PASS**, which stands for **P**ull, **A**im, **S**queeze, and **S**weep.

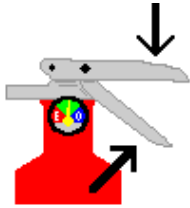

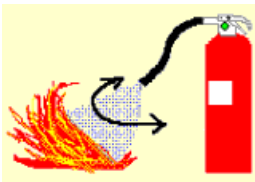
Pull the pin. This will allow you to operate the extinguisher.



Aim at the base of the fire. This is where the fuel is.



Squeeze the top handle or lever. This releases the pressurized extinguishing agent in the extinguisher.



Sweep from side to side until the fire is completely extinguished. Start using the extinguisher from a safe distance away, then move forward. Once the fire is out, keep an eye on the area in case it re-ignites.



The Fire Triangle

In order to understand how fire extinguishers work, you first need to know something about fire.

Fire is a chemical reaction involving rapid oxidation (burning) of a fuel

Four things must be present at the same time in order to produce fire:

1. **FUEL** - any combustible material - solid, liquid or gas. Most solids and liquids must vaporize before they will burn.
2. **OXYGEN** - Sufficient oxygen must be present in the atmosphere surrounding the fuel for fire to burn.
3. **HEAT** - Sufficient heat energy must be applied to raise the fuel to its ignition temperature
4. **Chemical, exothermic reaction** - This reaction can occur when all three of the above elements are present in the proper conditions and proportions. Fire (rapid oxidation) is the result of this chemical reaction.

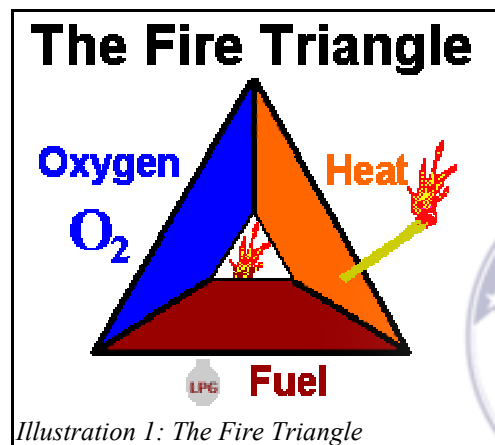


Illustration 1: The Fire Triangle

The combination of these three elements is frequently referred to as the "fire triangle". Add in the fourth element, the chemical reaction, and you actually have a fire "tetrahedron." The important thing to remember is that **if any one of these four things can be removed there will be no fire or the fire will be extinguished.**

Essentially, fire extinguishers put out fire by taking away one or more elements of the fire triangle/tetrahedron.








Fire safety, at its most basic, is based upon the principle of keeping fuel sources and ignition sources separate.

Classes of Fires

Fires are classified according to the material that is being burned. The four classes of fires, with the American and International symbols, are as follows:

 <p>ORDINARY A COMBUSTIBLES</p>  <p>A - Trash • Wood • Paper</p>	<p>Class A: Ordinary Combustibles - cloth, wood, paper, rubber, many plastics. Extinguisher: will put out fires in ordinary combustibles, such as wood and paper. The numerical rating for this class of fire extinguisher refers to the amount of water the fire extinguisher holds and the amount of fire it will extinguish.</p>
 <p>FLAMMABLE B LIQUIDS</p>  <p>B - Liquids • Grease</p>	<p>Class B: <u>Flammable Liquids - Gasoline, Oil, Oil-based paint, Cooking Oil.</u> Extinguisher: should be used on fires involving flammable liquids, such as grease, gasoline, oil, etc. The numerical rating for this class of fire extinguisher states the approximate number of square feet of a flammable liquid fire that a non-expert person can expect to extinguish.</p>
 <p>ELECTRICAL C EQUIPMENT</p>  <p>C - Electrical Equip.</p>	<p>Class C: Energized electrical equipment, including appliances, wiring, circuit breakers, and fuse boxes. Extinguisher: suitable for use on electrically energized fires. This class of fire extinguisher does not have a numerical rating. The presence of the letter “C” indicates that the extinguishing agent is non-conductive.</p>
 <p>COMBUSTIBLE D METALS</p>	<p>Class D: Combustible metals such as magnesium, sodium, lithium, hafnium, powdered aluminum, etc. Extinguisher: designed for use on flammable metals and are often specific for the type of metal in question. There is no picture designator for Class D extinguishers. These extinguishers generally have no rating nor are they given a multi-purpose rating for use on other types of fires.</p>

Part of the reason I teach fire safety in a computer class is because early models of AMD (American Micro Devices) CPUs (Central Processing Units) would actually catch fire if they lost cooling! Later models have evidently overcome this problem but I feel it is best to be prepared, just in case.

What is an Icon?

An **icon** is the part of the Windows Graphical User Interface (GUI) that represents a file or folder. It is composed of two parts, an image and a title.

On computer displays, a computer icon is a small pictogram. Icons have been used to supplement the normal alphanumeric of the computer. Modern computers now can handle bit-mapped graphics on the display terminal, so the icons are widely used to assist users.

Icons were first developed as a tool for making computer interfaces easier for novices to grasp in the 1970s at the Xerox Palo Alto Research Center facility. Icon-driven interfaces were later popularized by the Apple Macintosh and Microsoft Windows operating environments.

A computer icon usually ranges from 16 by 16 pixels up to 128 by 128 pixels. Some operating systems feature icons up to 512 by 512 pixels. When the graphical output device has a smaller size, the icon size is small. Vision-impaired users (due to such conditions as poor lighting, tired eyes, medical impairments, bright backgrounds, or color blindness) may need to utilize the self-selected icon size options.

Icons may represent a file, folder, application or device on a computer operating system. In modern usage today, the icon can represent anything that the users want it to: any macro command or process, mood-signaling, or any other indicator. User friendliness also demands error-free operation, where the icons are distinct from each other, self-explanatory, and easily visible under all possible user setups.

What is an Avatar?

An **avatar** is the computer user's representation of himself or herself, whether in the form of a three-dimensional model used in computer games, a two-dimensional icon (picture) used on Internet forums and other communities, or a text construct found on early systems such as MUDs (**Multi-User Dungeon, Domain or Dimension**). It is an "object" representing the embodiment of the user. The term "avatar" can also refer to the personality connected with the screen name, or handle, of an Internet user.

As used for a computer representation of a user, the term dates at least as far back as 1985, when it was used as the name for the player character in the Ultima series of computer games. The Ultima games started out in 1981, but it was in Ultima IV (1985), that the term "Avatar" was introduced. To become the "Avatar" was the goal of Ultima IV. The later games assumed that you were the Avatar and "Avatar" was the player's visual on-screen in-game persona. The on-screen representation could be customized in appearance. Later, the term "avatar" was used by the designers of the pen and paper role-playing game Shadowrun (1989), as well as in the online role-playing game Habitat (1987).

How to sit in front of your computer

How to use a mouse is almost inseparable from how to sit in front of your system display and keyboard, so we need to demonstrate and discuss that first.

1. The chair you sit in should be comfortable and adjusted so that you feet are flat on the floor. You should sit well back in the chair with your upper arms parallel to your body. Your forearms should be at an approximate 90 degree angle forward and parallel with the floor with your fingers at the right height to reach the keyboard **without** hunching your shoulders or reaching out to bring your upper arms away from your body. Any other position could lead to arm or shoulder strain. If you do a lot of touch typing, you will find it advantageous to center your body on the Main Keyboard portion of your keyboard.

2. Your eyes should be from 18" to 30" from the display and you should have your head positioned squarely over your shoulders looking either straight ahead or slightly down to see the display. Any other position could lead to headaches and/or neck strain.

3. The mouse should be on the side of the keyboard that corresponds to the hand you use primarily to write with. Usually that will be the right side. In class, unfortunately, it is too distracting to make exceptions for left-handed users but you will be taught how to make changes so you can convert your home system for left-handed use.

The mouse should be held perpendicular to the display screen for optimum control. That way, when the mouse is moved in any direction, the mouse pointer on your display will move in exactly the same apparent direction.

Below is a table that defines what different Mouse clicks accomplish.

Typical Mouse Click Table:

Button	Single Click	Double Click	2 Single Clicks	Hold
Left	Select	Run or Execute	1st - Select 2nd - Select (if on the Icon) - Rename mode (if on the title)	Drag

The term context menu is commonly used for menus which pop up when clicking an item in a graphical user interface, offering a list of options which vary depending on the context of the action, the application running, and the item selected. These menus are typically invoked with a secondary mouse button (usually the right-hand button) on a computer running an operating system such as Microsoft Windows. Computers with a single-button mouse may use a keyboard-click combination, as with a Control-click in Mac OS. PC keyboards with Microsoft Windows keys also have an additional menu key that opens context menus in MS Windows applications.

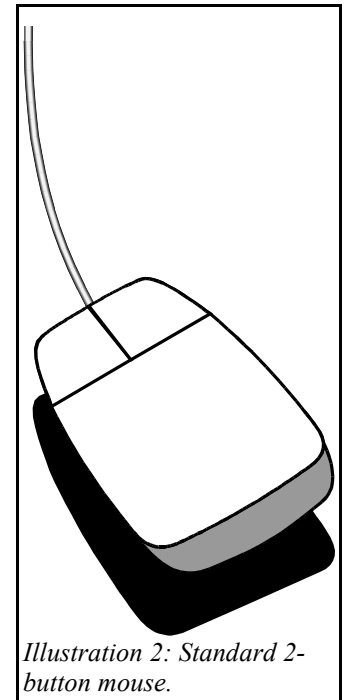


Illustration 2: Standard 2-button mouse.

Getting to Know PC Hardware

Understanding your PC starts by figuring out your PC's hardware. The figure below shows what a typical computer system looks like. A brief description of the basic computer parts and components follows.

- **Console:** The main computer box is the console, though some call it the *system unit*. It is a box that contains your computer's motherboard, CPU, memory, and various buttons, lights, and holes into which you plug the rest of the computer system.
- **Monitor:** The monitor is the TV-set-like thing on which the computer displays information. It sits to the right or left of the console, or if you put the console beneath the table, the monitor sits on top of the table.

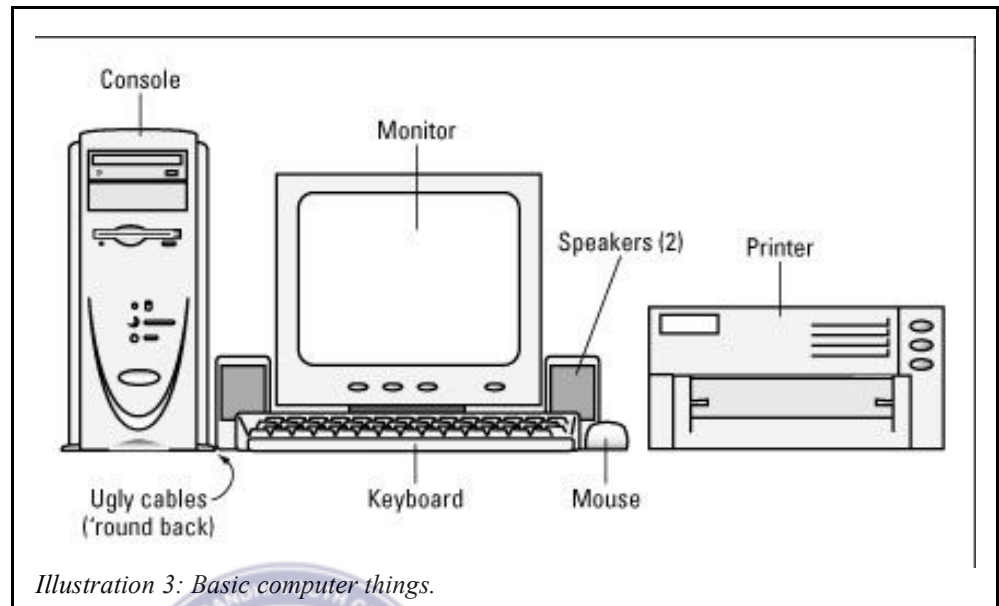
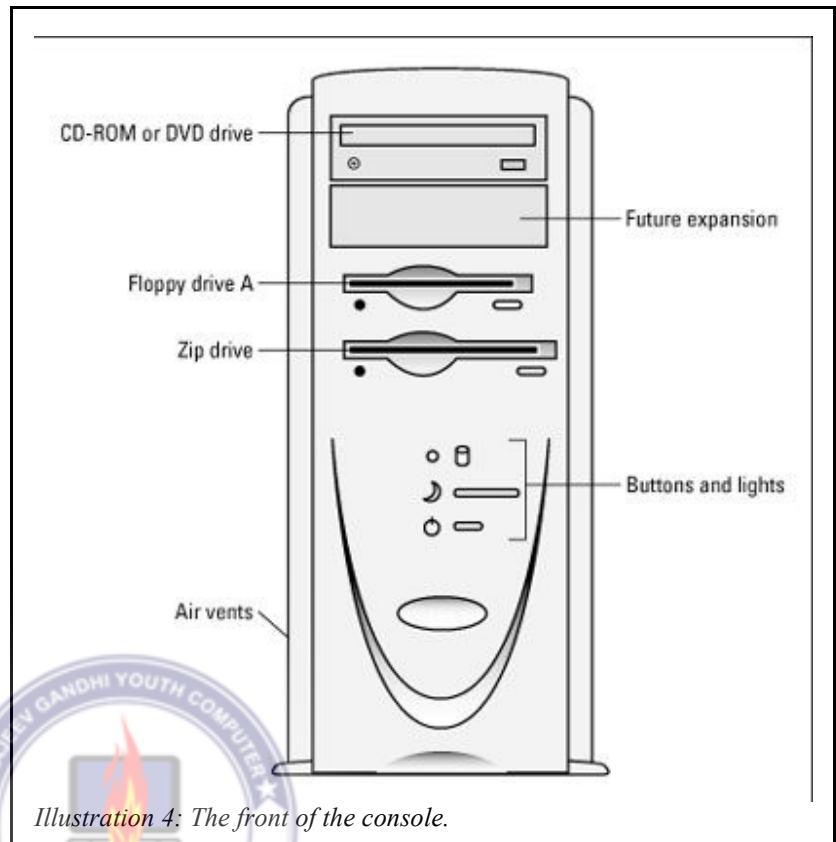


Illustration 3: Basic computer things.

- **Keyboard:** This is similar to a typewriter keyboard.
- **Mouse:** This is a helpful hand-held device that lets you work with graphical objects that the computer displays on the monitor's screen.
- **Speakers:** Most PCs can bleep and squawk through a set of stereo speakers, either externally devices you can set up, as shown in the Figure above, or built into the console or the monitor. Pay more money, and you can even get a sub-woofer to sit under the desk.
- **Printer:** This is where you get the computer's output: the paper printout, also called *hard copy*.

Diagram of a Console (front)

The console is the most important part of your computer. It's the main thing, the Big Box. Every part of your computer system either lives inside the console or plugs into it. The figure to the right shows what a typical PC console may look like. I've flagged the more interesting places to visit, although they may appear in a different location than shown in the figure.



- **CD-ROM or DVD drive:** These high-capacity discs look exactly like musical CDs, although they contain computer information. DVD drives have the DVD symbol on them. If you don't see the DVD symbol, then your PC has a mere CD-ROM drive. That's okay for now, because little software is available exclusively on DVD discs.
- **Future expansion:** Any blank spots or covers on the front of your computer means that you can add more features later. Such a space may already be taken, filled with such extras as a tape backup unit, Dip Drive; another CD-ROM drive, another hard drive, or an assortment of other assorted options.
- **Floppy Drive:** This slot accepts Floppy Disks. Some software comes on Floppy Disks, and you can use these disks to move files from one PC to another.
- **Super Drive:** An option that accepts normal Floppy Disks but will also accept special 120 MB Super Disks.
- **Zip Drive:** A common option found on many PCs is the Zip Drive, which is like a super Floppy Drive. On a Zip Disk, you can store the equivalent of 100 Floppy Disks worth of information. Not every PC has a Zip Drive however.
- **Air vents:** Most consoles sport some type of air vent on the front. Do not block the air vents. The console needs proper ventilation to keep cool.

Diagram of a Console (back)

The back of the console is where you find the computer's busy side. That's where you find various connectors for the many other devices in your computer system: a place to plug in the monitor, keyboard, mouse, speakers, and just about anything else that came in the box with the PC. The illustration to the right shows where and how the various features can connect. Your computer should have most of the items shown in the figure, although they may be in different locations.

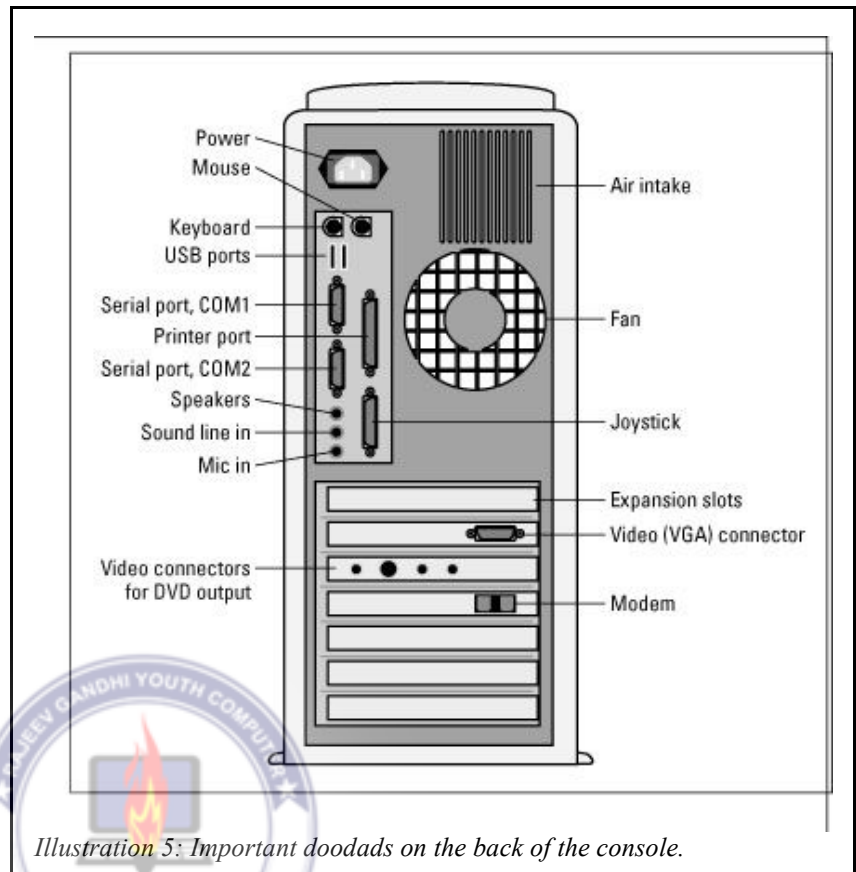


Illustration 5: Important doodads on the back of the console.

- **Power connector:** This is where the PC plugs into a cord that plugs into the wall outlet.
- **Keyboard connector:** The keyboard plugs into this small port. The small picture is supposed to be a keyboard.
- **Mouse connector:** It's generally the same size and shape as the keyboard connector, although this has a mouse icon nearby.
- **USB port:** Plug **USB** devices into these rectangular slots.
- **Serial, or COM, ports:** Most PCs have two of these ports, labeled COM1 and COM2. This is where an external modem or sometimes a mouse is plugged in. They usually consist of a connector with 9 holes.
- **Printer port:** The PC's printer plugs into this connector.
- **Joystick port:** This port may be used for different applications. The port may be identified by an image, or it may say Joystick or Game controller.
- **Monitor connector:** Your PC's monitor plugs into this port. Sometimes the port is on an expansion slot and is unlabeled. If so, you can tell what the monitor connector is because it has 15 tiny holes in it arranged in 3 rows.
- **Speaker/Sound-out jack:** It is where you plug in your PC's external speakers or where you would hook up the PC to a sound system. (If you have USB speakers, then you should use the USB port for external speakers.)
- **Line-in jack:** This jack is where you plug in your stereo or VCR to the PC for capturing sound.
- **Microphone jack:** The computer's microphone plugs into this hole.
- **Modem:** Two connectors live on the modem. One is for connecting the modem to the phone jack in your wall, and the other is to connect a telephone so that you can answer the phone.
- **S-Video out:** If your PC sports a DVD drive, it probably has several additional connectors for video output. The S-Video connector allows you to connect an S-Video TV to your PC. Other video connectors let you transfer a DVD movie out to a TV set or VCR.
- In addition to the ports, jacks, and holes on the back of the console are expansion slots. They're the back of various expansion cards you plug into your PC. Some expansion slots have connectors for other PC devices as well.

The Desktop

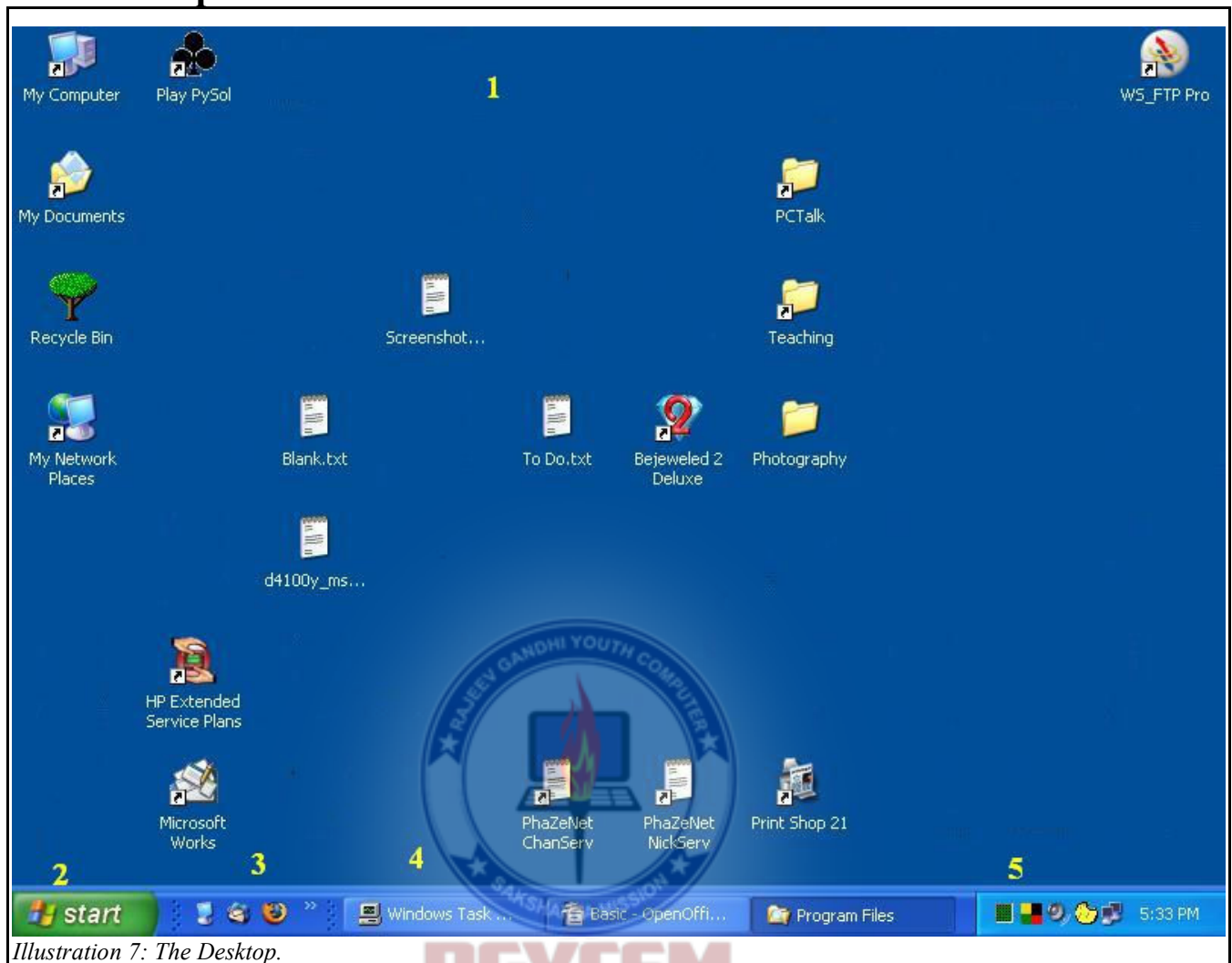


Illustration 7: The Desktop.

1. The desktop is just another window. It is the first window that opens when the Operating System (OS) starts however and everything else is displayed on top of it, including other windows and Icons. It is called a Graphical User Interface (GUI).
2. The Start Button, the first button on the Task Bar, contains several menus which allow you to access almost everything on your computer, depending upon your personal accesses.
3. The Quick Launch Bar is available to place your most often used files on by dragging and dropping their Icons into it to enable you to access them with a single Click.
4. The Active Task Bar area is where all buttons for currently open files are located. The buttons get smaller and harder to read as the number of open files grows.
5. The Notification area on the right contains mainly icons that convey status information as well as the clock if it is selected to be displayed.

Parts of a Window

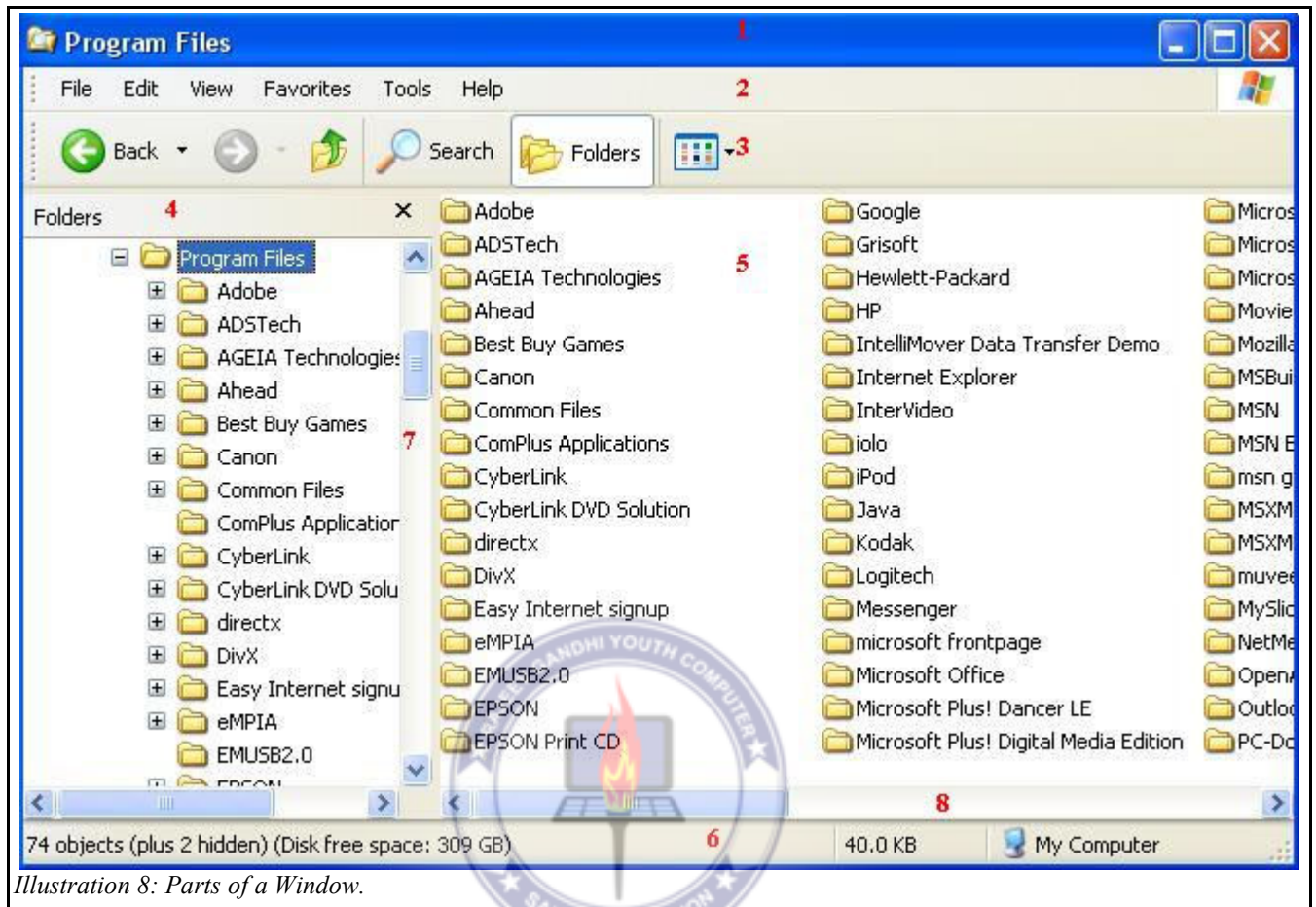


Illustration 8: Parts of a Window.

In the Illustration above, certain areas are numbered for easy reference. I will explain what each numbered area is and enumerate all of its different options. Some of the information is specific to this particular window and some is generic to all windows. I will be discussing each numbered area's features either from left to right or from top to bottom.

Parts of a Window Table

	Name	Description
1	Title Bar	<p>First, there is a small icon that looks like a file folder. This is a menu that offers some minimal window control options one of which is Close. Next is the Title of the Window. This can include not only the name of the folder being viewed but may also contain the name of a program being used and/or a file name.</p> <p>On the far right are three square buttons. The first is a minimize button. This will remove the window from the desktop and place a reference button for the window on the taskbar. The second square button is the maximize/restore toggle button. It will appear as a square if it is set to maximize the window. It will look like two boxes, one superimposed on the other, if the window is already maximized and can be restored to its previous size. The last square button is a white "x" in a red box. This will close the window.</p> <p>The entire title bar will act as a large maximize/restore button if you double-click on any part of it that is not a button or a menu.</p>
2	Menu Bar	Contains menu words. When the words are selected, they will open into a menu indicated by the word.
3	Icon Bar	Contains the most often used sub-set of the commands found in the Menu Bar.
4	Left Pane	The left portion of the display area. This section shows the folder structure of your storage devices.
5	Right Pane	The right portion of the display area. This section shows the file and folder content of the folder selected in the left pane.
6	Status Bar	Displays information about the currently selected file or folder.
7	Vertical Scroll Bar	<p>The Vertical Scroll bar only appears if there is so much information to display that not all is visible at once. The ▲ button moves the window up one line at a time.</p> <p>The Slider is the colored bar in between the left and right arrow buttons. It will allow you to drag the display very quickly left or right.</p> <p>The ▼ button moves the window down one line at a time.</p> <p>The area between the end buttons and the edges of the slider will move the pane one page at a time either up or down depending upon which side you click on.</p>
8	Horizontal Scroll Bar	<p>The Horizontal Scroll bar only appears if there is so much information to display that not all is visible at once. The ◀ button moves the window to the left one character at a time (left pane) or one column at a time (right pane).</p> <p>The Slider is the colored bar in between the left and right arrow buttons. It will allow you to drag the display very quickly left or right.</p> <p>The ▶ button moves the window to the right one character at a time (left pane) or one column at a time (right pane).</p> <p>The area between the end buttons and the edges of the slider will move the pane one page at a time either left or right depending upon which side you click on.</p>

Recommended Settings for Outlook Express

Note: This section is out of order as many students have an immediate need for email. Herein will be explained how to setup and use email safely.

Recommended Preliminary Procedure for protection against viruses:

- Click on Outlook Express on Task Bar. This brings up Microsoft Outlook Express.
- Click on View, click on Layout. Opens an Options box.
- If checked, uncheck Contacts.
- If checked, uncheck Preview Pane.
- Press OK.

You do not want the Preview Pane because if an email is selected (highlighted) in the upper window, it will automatically open in the Preview Pane at the bottom. Many email viruses can be triggered to infect your computer when the email is opened.

Open Local Folders on left-hand pane.
Click on Inbox.

To look at an email in OE (Outlook Express) without opening it:

1. Right-click on email header (title).
2. Select Properties (bottom of context menu).
3. Select Details
4. Select Message Source
5. Maximize Message Source window if desired. This shows you what the email looks like.

There are three ways to open a file or program (or email):

1. Double-click on the icon, or
2. Single-click on icon and press Enter, or
3. Right-click on icon and select (single left click) Open.

Recommended Settings for using Outlook Express 6.0 (Earlier versions do not have all these options.)

Click on Tools in Menu Bar

Go to Options. There are ten Tabs:

1. General Tab

Uncheck “Send & Receive messages at startup” Never automatically send and receive emails as a virus could be sent to everyone in your address book if your computer is infected.

Uncheck “Check for new messages everyminutes.”

Check “When starting, go directly to my “inbox” folder.

Check “Automatically display folders with unread messages.”

Note: These are the only two options recommended to be checked in this section.

2. Read Tab

Check “Mark messages read after displaying for seconds”

Uncheck “Automatically download message when viewing in the Preview Pane”

3. **Receipts Tab**

Check “Notify me for each read receipt request”

4. **Send Tab**

Check “Save copy of sent messages” (Good to have!)

Uncheck “Send messages immediately” (Reduces possibility of sending a virus)

Leave everything else checked

Mail Sending Format: Click on Plain Text (Do not check HTML).

5. **Compose Tab**: Leave as is, default setting OK.

6. **Signatures Tab**: Leave as is, default setting OK.

7. **Security Tab**: Security Default OK. Leave as is.

8. **Connection Tab**: Make sure **Ask before switching dial-up connections** is checked.

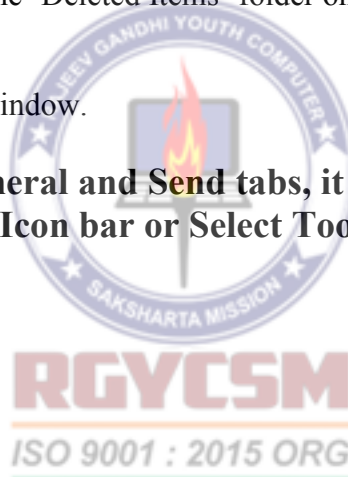
9. **Maintenance Tab**

Uncheck “Empty messages from the ‘Deleted Items’ folder on exit”

Leave everything else unchecked.

Click on OK to Exit to main OE window.

With the changes to the General and Send tabs, it will be necessary to click on the Send/Receive button on the Icon bar or Select Tools\Send and Receive All, in order to send and receive Email.



Email Client Tips

These tips are aimed specifically at Outlook Express that comes bundled with Windows but, with some slight alteration, should work with many other email clients such as Outlook, Mozilla Thunderbird, and Novell NetMail to name just three.

- Keep your Inbox as empty as possible so it doesn't start to feel overwhelming.
- Create sub-folders to hold incoming email.
- Create message rules to automatically sort your incoming email for you.

Creating sub-folders to help sort incoming emails:

- Right-click on Local Folders to bring up a menu,
- From the menu select New Folder,
- Give your new folder an appropriate name and press the enter key.

Creating Mail Message Rules to sort incoming emails directly to appropriate folders (instead of going into the Inbox):

- Create an appropriate sub-folder for your Mail Message Rule to place incoming email,
- From the Menu Bar select **Tools**,
- From the Tools Menu highlight Message Rules, slide over to the new menu and select **Mail...**,
- Click on the New button which is on the right of the resulting window,
- A new window opens titled "**New Mail Rule**". In this window you will accomplish five tasks:
 1. Select the conditions for your rule. I usually only select "**Where the From line contains people**",
 2. Select the actions for your rule. I usually only select "**Move it to the specified folder**",
 3. Single left-click on **contains people** and enter the information exactly as it appears in the received email header,
 4. Single left-click on **specified** and select the folder for new incoming email to be moved into. You may have to single left-click on the plus (+) sign in front of **Local Folders** to see all the locations that are available.
 5. Highlight the information below "**Name of the rule:**" and give your new rule a name that makes sense to you so you can remember what it does.
- 6. Click on OK to finish the rule.
- 7. If you wish, Select Modify to check what you have typed.

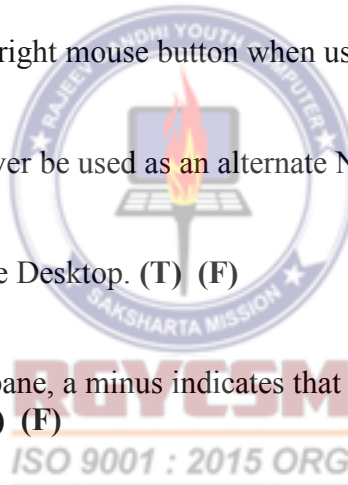

Web Browsers

Note: This section is out of book order but needs to be covered early due to the availability of the Class website and Forum. A Forum may be thought of as similar to the bulletin board found at the entrance to many super markets where people list things for sale or to be given away. Early forums were known as Bulletin Board Systems (BBS).

A web browser is a software application which enables a user to display and interact with text, images, videos, music and other information typically located on a Web page at a website on the World Wide Web or a local area network. Text and images on a Web page can contain hyperlinks to other Web pages at the same or different website. Web browsers allow a user to quickly and easily access information provided on many Web pages at many websites by traversing these links. Web browsers format the HTML (Hypertext Markup Language) information for display, so the appearance of a Web page may differ between browsers.

Some of the Web browsers available for personal computers include Internet Explorer, Mozilla Firefox, Safari, Opera, Flock and AOL Explorer, in order of descending popularity (in March 2008). Web browsers are the most commonly used type of HTTP (Hypertext Transport Protocol, one of the ways information is transmitted over the Internet) user agent. Although browsers are typically used to access the World Wide Web, they can also be used to access information provided by Web servers in private networks or content in file systems.

Microsoft vs Netscape

In 1996, Netscape's share of the browser market reached 86% (with Internet Explorer edging up 10%); but then Microsoft began integrating its browser with its operating system and bundling deals with OEMs (Original Equipment Manufacturers), and within two years the balance had reversed. Although Microsoft has since faced antitrust litigation on these charges, the browser wars effectively ended once it was clear that Netscape's declining market share trend was irreversible. Prior to the release of Mac OS X, Internet Explorer for Mac and Netscape were also the primary browsers in use on the Macintosh platform.

Unable to continue commercially funding their product's development, Netscape responded by open sourcing its product, creating Mozilla. This helped the browser maintain its technical edge over Internet Explorer, but did not slow Netscape's declining market share. Netscape was purchased by America Online in late 1998. At first, the Mozilla project struggled to attract developers, but by 2002 it had evolved into a relatively stable and powerful Internet suite. Mozilla 1.0 was released to mark this milestone. Also in 2002, a spin off project that would eventually become the popular Firefox was released.

In 2003, Microsoft announced that Internet Explorer would no longer be made available as a separate product but would be part of the evolution of its Windows platform, and that no more releases for the Macintosh would be made.

AOL announced that it would retire support and development of the web browser, Netscape, in February 2008, and encouraged users to use Mozilla Firefox or Flock.

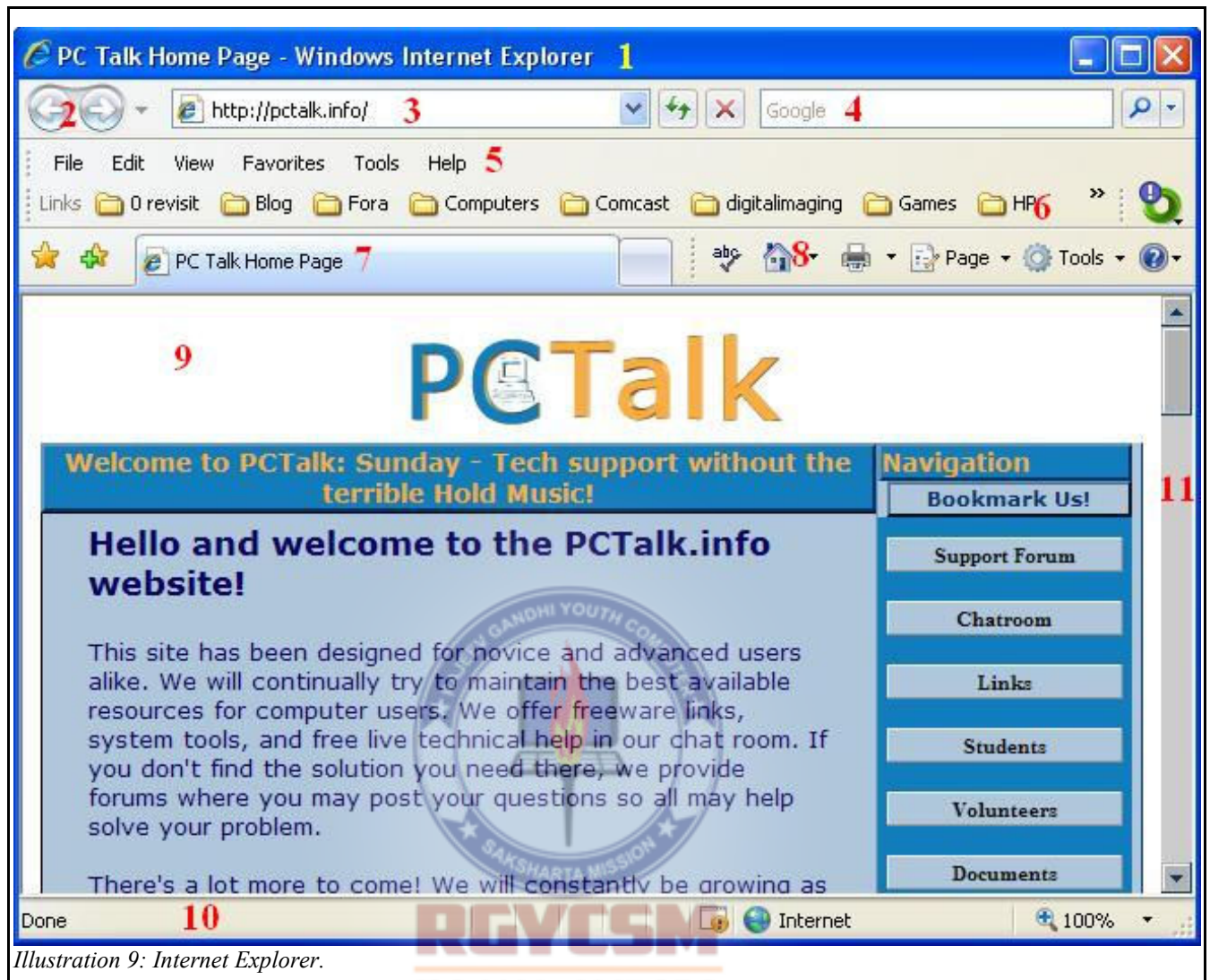


Illustration 9: Internet Explorer.

Proprietary features

Internet Explorer has introduced an array of proprietary extensions to many of the standards, including HTML, CSS (Cascading Style Sheet) and the DOM (Document Object Model). This has resulted in a number of web pages that can only be viewed properly using Internet Explorer. Some view this as an example of what is called “embrace, extend and extinguish” (EEE), a way to drive competitors out of business by forcing them to use proprietary technology that Microsoft controls, resulting in vendor lock-in.

Table of Browser components.

Most of the numbered areas shown in the Browser Illustrations correspond fairly closely to similar areas for the Windows Explorer Illustration. I will be talking mostly about the differences here.

	Name	Description
1	Title Bar	Same as for Windows Explorer.
2	Previous /Next Buttons	Previous: Return to the previously visited web page. Next: Return to a web page after using the Previous button.
3	Address Bar	The address (URL) of the current web page. May also be used to type in an address of a page to be visited.
4	Search Bar	Type in one or more words to perform a search for specific information on the Internet.
5	Menu Bar	Same as for Windows Explorer.
6	Links Bar	A list that you can personalize of visited Internet Websites.
7	Tabs	Tabs are a relatively new option allowing you to open multiple windows using the same Browser instance. Each instance will appear in a different tab instead of a new window.
8	Icon Bar	Same as for Windows Explorer.
9	Document Display	This is where the HTML document you have accessed, whether on your local computer or on the Internet, is displayed.
10	Status Bar	Various information may be displayed here. The most useful is the URL of any link you hover over.
11	Vertical Scroll Bar	Same as for Windows Explorer.



Mozilla Firefox

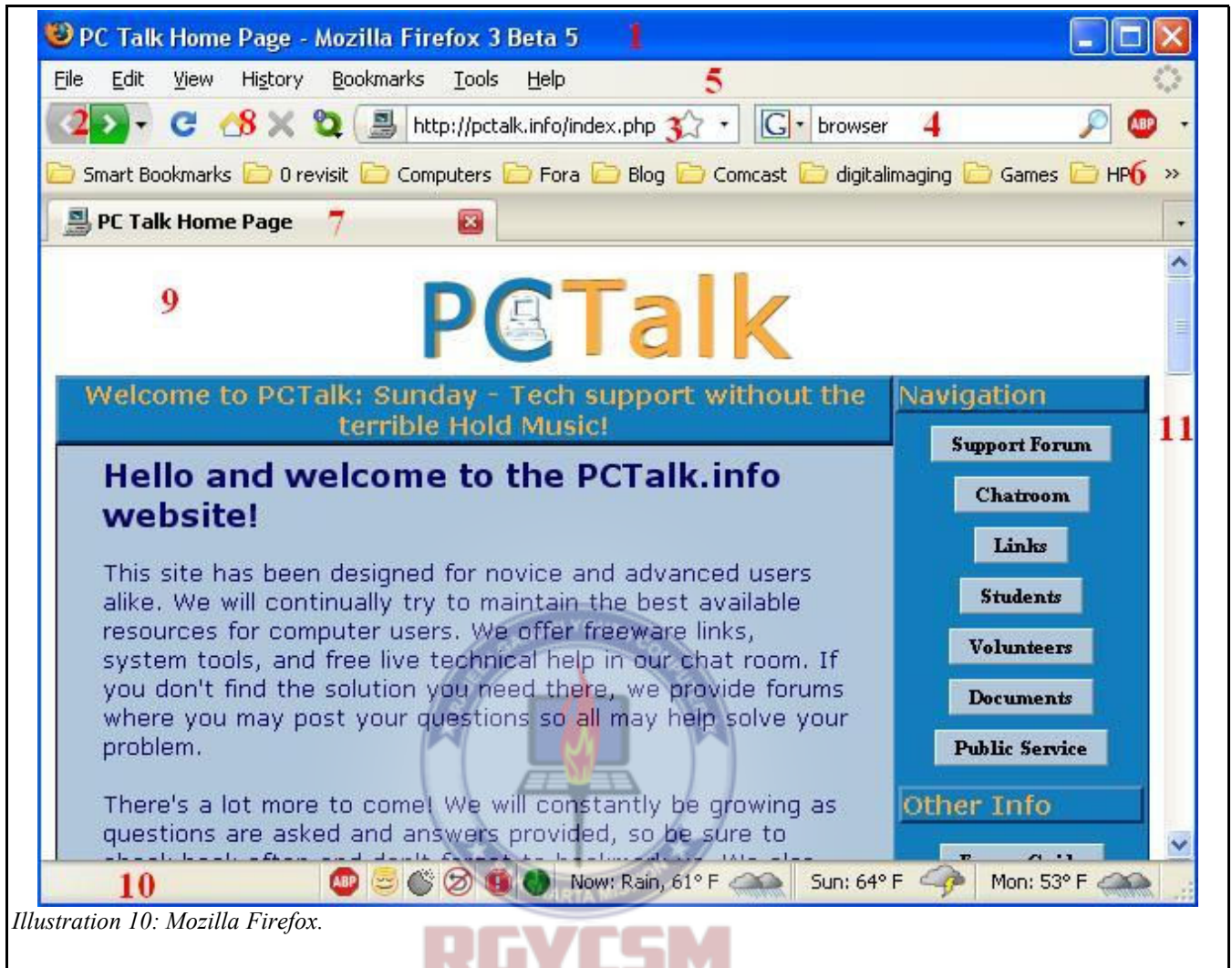


Illustration 10: Mozilla Firefox.

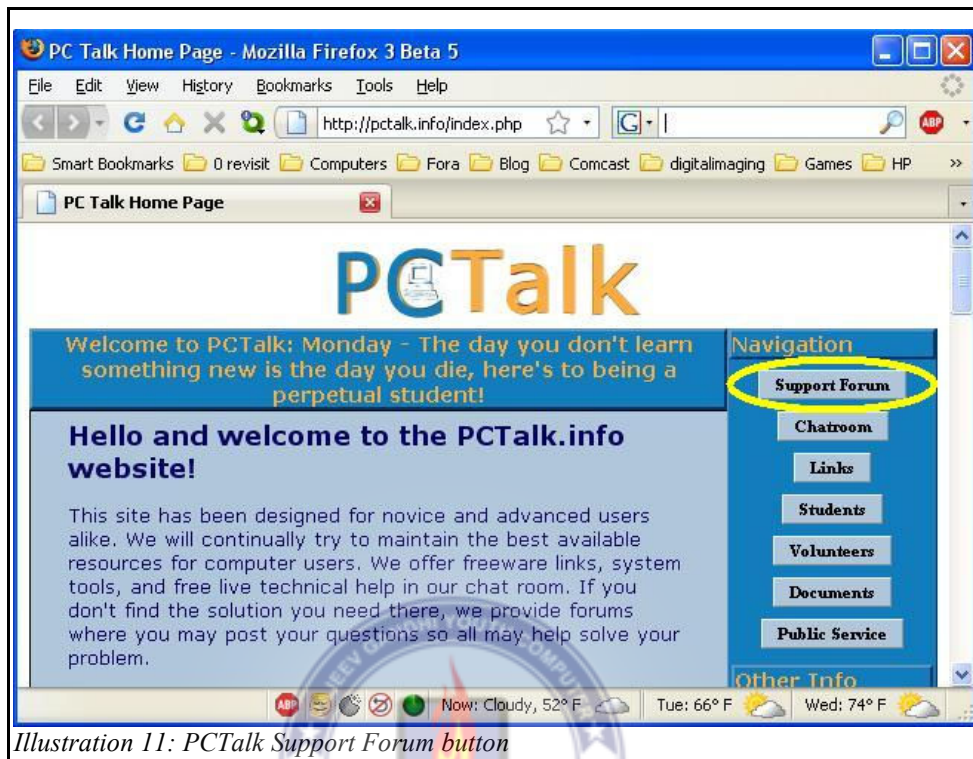
Mozilla Firefox (Version 3B5 shown here) is a Web Browser. Mozilla Firefox, is a web browser descended from the Mozilla Application Suite, managed by the Mozilla Corporation. Firefox had 17.76% of the recorded usage share of web browsers as of April 2008 which is about 70 million people, making it the second-most popular browser in current use worldwide after Internet Explorer. Firefox uses the open source Gecko layout engine, which implements some current Web standards plus a few features which are intended to anticipate likely additions to the standards.

Firefox includes tabbed browsing, a spell checker, incremental find, live bookmarking, a download manager, and an integrated search system that uses the user's desired search engine. Functions can be added through around 2,000 add-ons created by third party developers; the most popular include **NoScript** (script blocker), FoxyTunes (controls music players), **Adblock Plus** (ad blocker), StumbleUpon (website discovery), DownThemAll! (download functions) and Web Developer (web tools). Firefox's source code is free software, released under a tri-license GPL/LGPL/MPL.

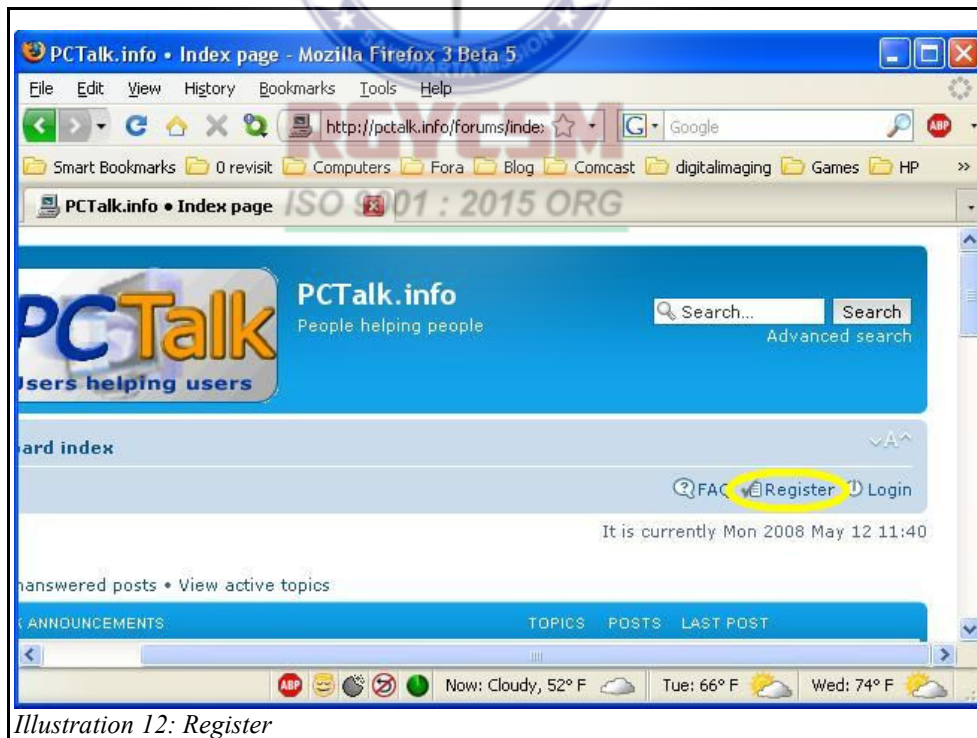

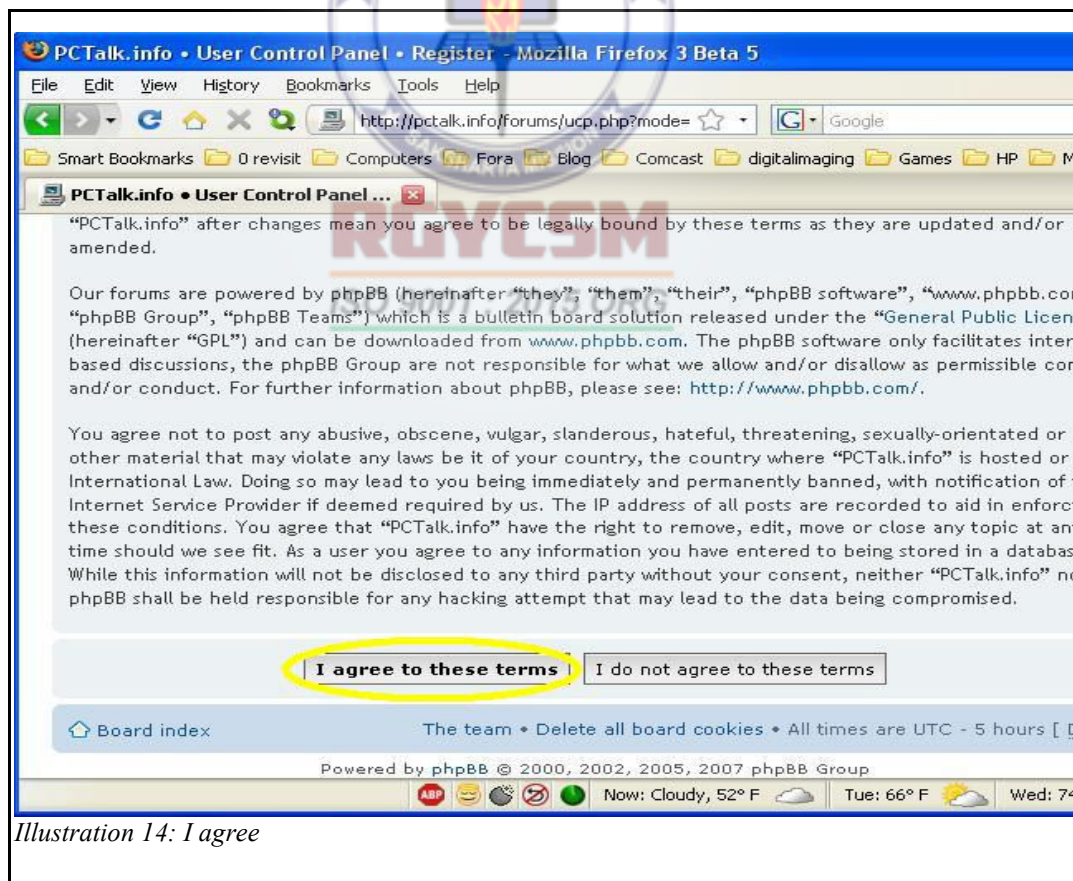


Illustration 14: I agree

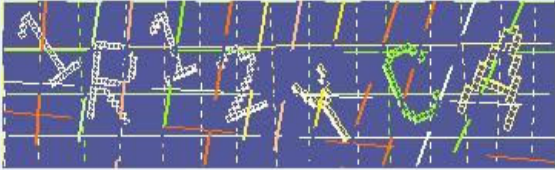

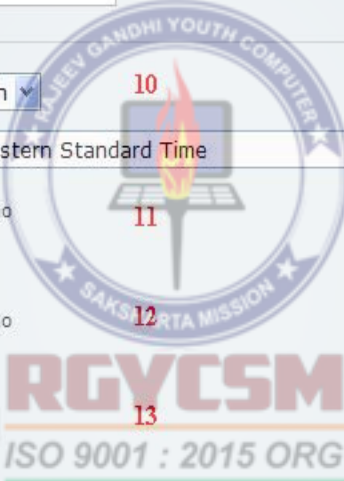


Illustration 15: Registration Form

You should receive an email shortly welcoming you to the forum and repeating for you the Username and Password you used to register. Keep it in a safe place for future reference in case you forget your password. Once you receive your registration email, there will be a link in the email you must click on to activate your new account. Once that is done, you may now login to the forum.

Logging in to the forum

- 1) Open your Browser and go to <http://pctalk.info/>,
- 2) Click on the Support Forum button in the Navigation Bar on the right,
- 3) Click on the Login link on the right of the page or, if you prefer, there is a place for your username and password at the bottom of the page,

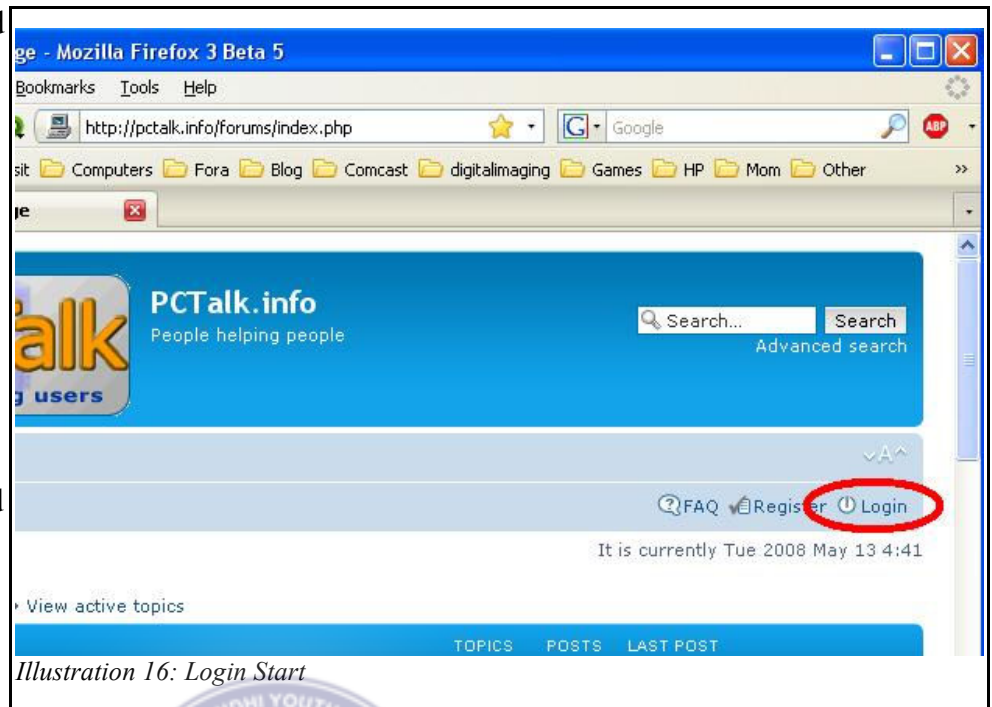


Illustration 16: Login Start

- 5) Enter your Password (remember, case counts),
- 6) If you have forgotten your password and lost your registration email, you can click on the "I forgot my password" link to receive a reminder to the same email address you registered with,
- 7) If you are using a safe computer that no one else uses and is password protected, you might want to select the "Log me on automatically each visit" selection box. Please never do this on a public computer or one where others may gain access to your account,
- 8) There is another select ion box that you should probably never select. That is the "Hide my online status this session". It hides your online identity to other forum members and the public only. All Admins and Moderators will know who you are regardless but none of the other members will know you are there,

9) Click on the Login button to now gain access to the forum.

When you first access the forum, you will be in a purgatory area called Prospective Members. This is an area that is hidden to the public and to all full forum members. It is what I call part of my Spam Trap. You must make at least one post there telling me who you are, where you found out about the forum, and why you want to join before I move you up to full membership. While restricted to the Prospective Members forum, you will have very limited access to the forum tools.

As members of my class, I will know what your usernames are, so almost anything will be accepted but your "acceptance post" will be moved out of Prospective Members and into the New Users forum as a form of introductory post to let the other forum members know who you are. **You should never give any personal information** but you might want to give enough so others with similar interests will want to strike up a friendship.



Help with using the forum



- 1) You are now logged into the forum, you know this because you can see the Logout link next to your username.
- 2) There is a Frequently Asked Questions (FAQ) link that may answer some of your questions about how to use a forum.
- 3) Every time I login to the forum, the first link I click on is the "View new posts" link to see what has been posted since I was last in the forum. I find that if I do that every time I login, I will be able to keep up with what has been happening. If you login and then logout almost immediately, all posts will be marked as read, even if you haven't read them. The link should probably indicate, "View new posts since last login" to be most accurate.
- 4) There is a User Control Panel (UCP) where you may update certain information about your account such as changing your password, adding or changing an avatar, etc. If you change your email address, you will be locked out of the forum until your new email is verified, so it is not a good idea to change it unless you let me know first as the re-authorization process is manual.
- 5) There is an area where any new Personal Messages (PM) will appear. Click on the link to access old, new, and sent. There is a limit to how many of each may be stored on the forum. Once that limit is reached, old ones will be removed to make room for new ones. If you want to keep any for any reason, you might want to selectively prune them yourself.

Emoticons

A portmanteau (a word which fuses two or more function words) of the English words emotion (or emote) and icon, an emoticon is a symbol or combination of symbols used to convey emotional content in written or message form. The National Telegraphic Review and Operators Guide in April 1857 documented the use of the number 73 in Morse code to express "love and kisses" (later reduced to the more formal "best regards"). Dodge's Manual in 1908 documented the reintroduction of "love and kisses" as the number 88. Gajadhar and Green comment that both Morse code abbreviations are more succinct than modern abbreviations such as LOL. Typographical emoticons were published in 1881 by the U.S. satirical magazine Puck.

The creator of the original ASCII (American Standard Code for Information Interchange) emoticons :-) and :-(, with a specific suggestion that they be used to express emotion, was Scott Fahlman; the text of his original proposal, posted to the Carnegie Mellon University computer science general board on 19 September 1982 (11:44), was considered lost for a long time. It was however recovered twenty years later by Jeff Baird, from old backup tapes.

On the Internet nobody has any way of knowing how you feel about your comments, whether funny, sad, sarcastic, etc. e.g. "Brian is a real dummy!" You can add faces after your comment, such as:

An equal sign is often used for the eyes in place of the colon, without changing the meaning of the emoticon. In these instances, the hyphen is almost always either omitted or, occasionally, replaced with an 'o' as in =O). In some circles it has become acceptable to omit the hyphen, whether a colon or an equal sign is used for the eyes. In other areas of usage, people prefer the larger, more traditional emoticon :-). In general, similar-looking characters are commonly substituted for one another: for instance, o, O, and 0 can all be used interchangeably, sometimes for subtly different effect.

A few people turn the smiley around, a "left-handed" smiley (:

When you type an emoticon on the PC Forum it comes up as a picture, such as a smiley face, when posted. There are hundreds of emoticons, different types and sizes. Check out:

- 1) From the Desktop, use the Tab key until the Start button is selected and press the Enter key,

Windows Explorer is now open and active with the cursor in the left pane highlighting My Documents. Once the cursor is in the right pane, use the arrow keys to select the file you wish to open and press Enter to open it.

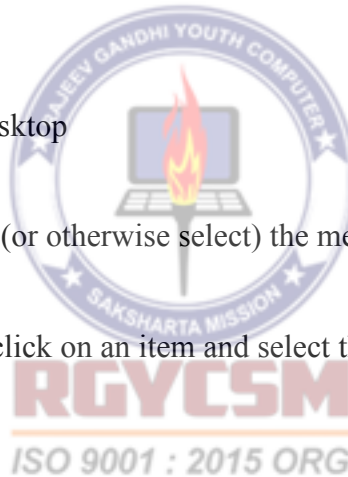
Using Alt-F4 will close successive active windows until you eventually get to the main Desktop and will offer to shut down the entire computer if you desire.

Display Properties, Themes

The Display Properties images used here are for Windows XP. Windows XP has 6 tabs rather than 5 but the overall contents are very similar. The only tab missing here is the Web tab which is contained in the Desktop tab for Windows XP.

- 1) Find an area of your Desktop that is clear of any windows or icons and Right-Click on it,
- 2) Select Properties from the resulting Context Sensitive Menu,
- 3) The Display Properties window opens with the Themes tab selected.
- 4) From this page, you may select any Theme available in the drop-down menu,
- 5) Save your current Desktop settings as your own personal theme which you may recall at any time if one or more of your preferred settings somehow gets changed.
- 6) You may also Delete any Themes which you have created that you no longer wish to save. I do not recommend deleting any of the default themes as you may wish to use them at some future date.
- 7) Once you select a theme different from the current one, the Apply button at the lower right becomes available. Simply click on it to apply the new Theme to your Desktop while leaving the Display Properties window open, or click on OK to apply the new Theme and close the Display Properties window.

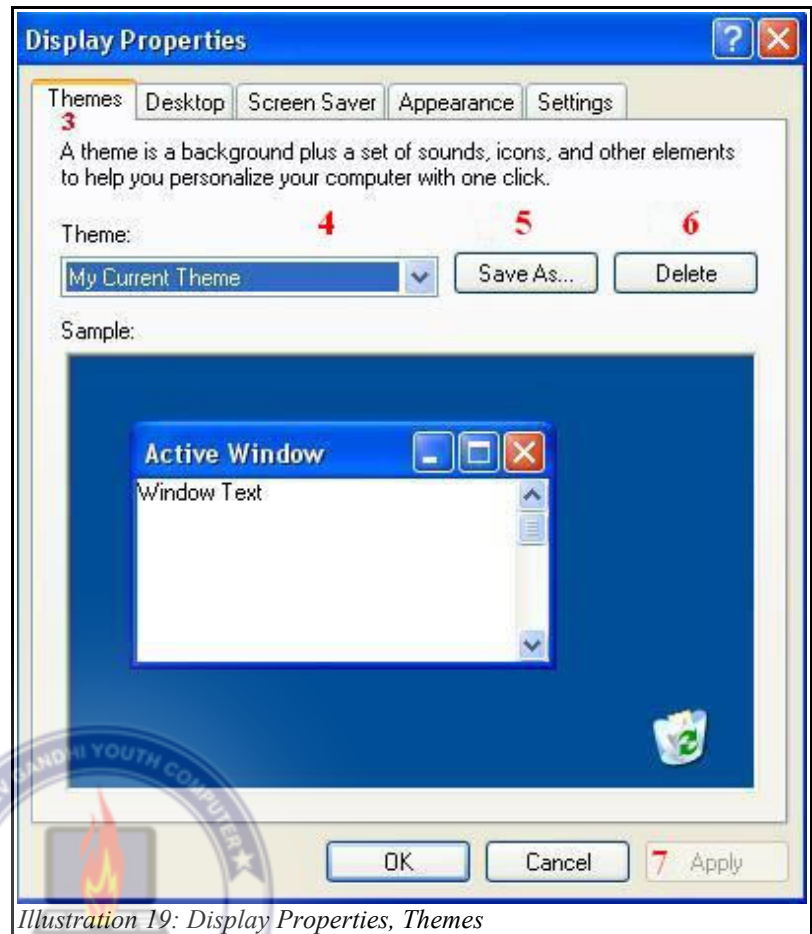
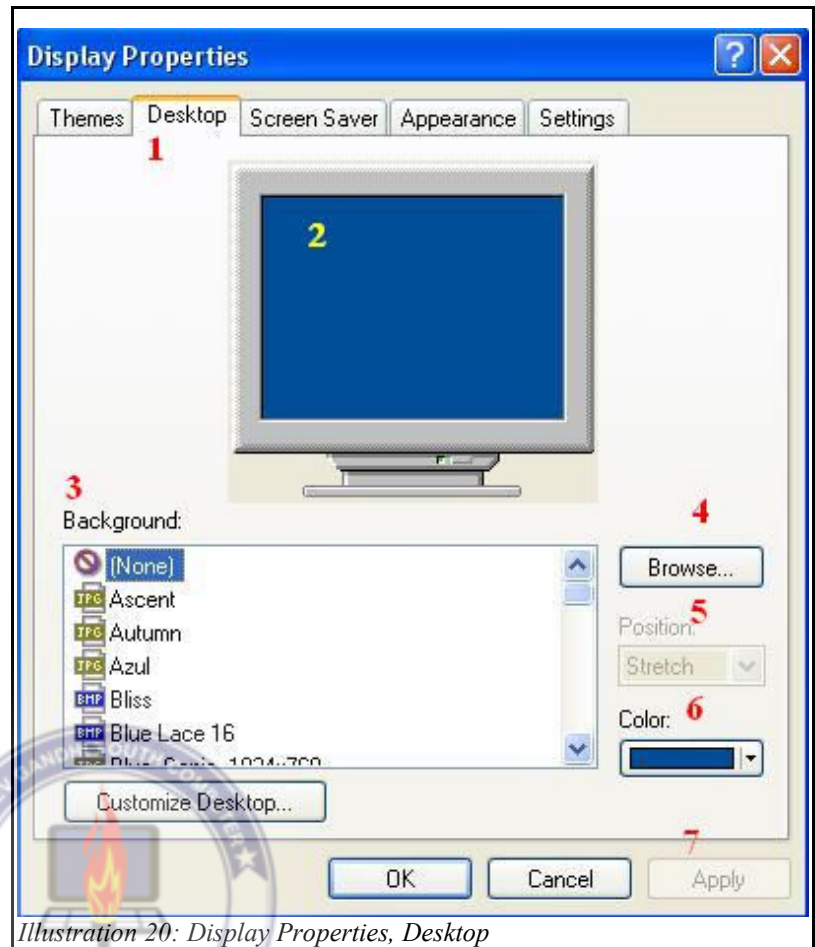


Illustration 19: Display Properties, Themes

Display Properties, Desktop

- 1) Click on the Desktop tab,

Desktop Properties, General

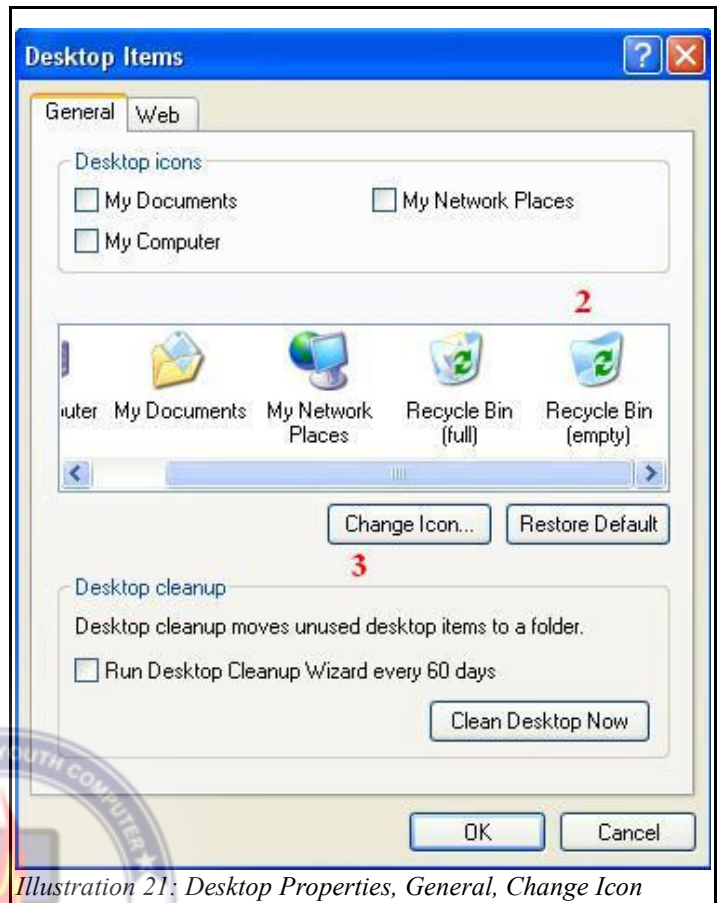
The Windows XP Customize Desktop button under the Desktop Tab combines two different sections; Desktop\Customize Desktop\General, and Desktop\Customize Desktop\Web. Of particular interest under the General tab is the section where you can change some of your desktop Icons. We will use this option to change the Recycle Bin (empty) to one that is a little more obvious.

- 1) Open the Desktop Properties\Effects tab,
- 2) Click on the Recycle Bin (empty) icon,
- 3) Click on the Change Icon button,
- 4) A Change Icon window opens. If it does not open with the file shell32.dll already selected, click on the Browse button and navigate to the Windows folder system32 and select the file shell32.dll,
- 5) Scroll to the right until you see a tree icon, click on it,
- 6) Click on the OK button on the Change Icon window,
- 7) Click on the Apply button in the Effects tab to cause your changed icon to take effect.

This window has excellent examples of controls:

Display Properties, Screen Saver

- 1) Click on the Screen Saver tab,
- 2) Select a Screen saver from the Screen saver Drop-down Menu,
- 3) Click on Preview if you want to see what your new Screen saver will look like. Move your mouse or press a key to go back to the Display Properties window,
- 4) Use the **Spin Box** up and down arrows to set the time in minutes until the Screen saver activates or simply type in the minutes in the text box to the left,
- 5) If you want your Screen saver to be password protected, click on the **Check Box** to place a check mark in it,
- 6) If you want to change how your selected Screen saver displays, click on the **Settings button** to make changes,

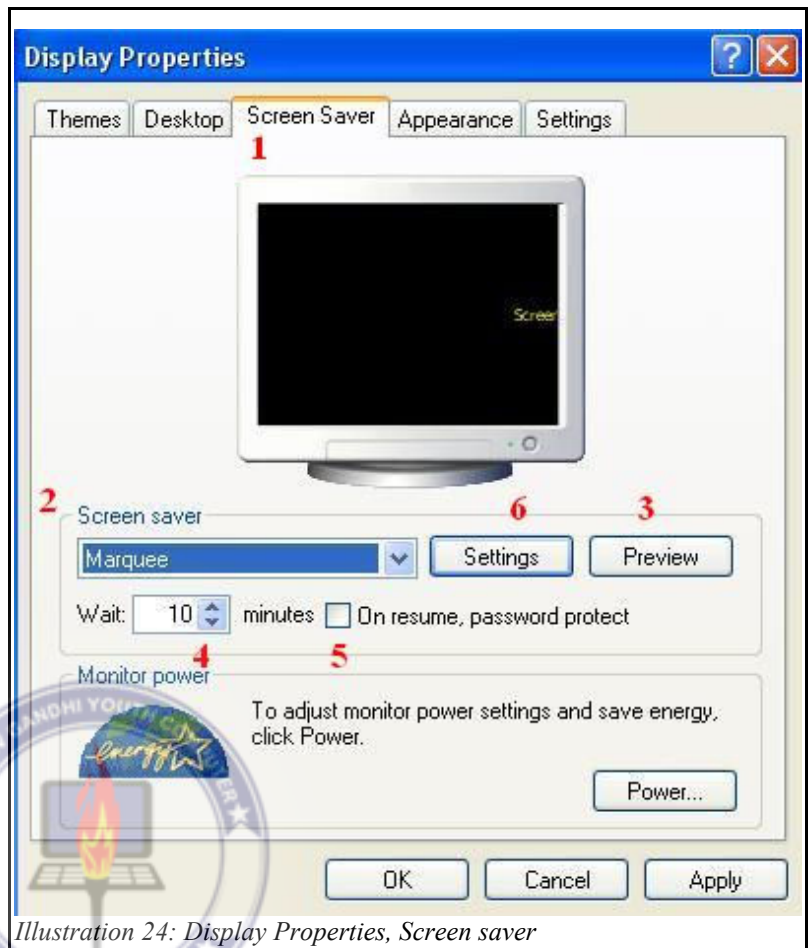


Illustration 24: Display Properties, Screen saver

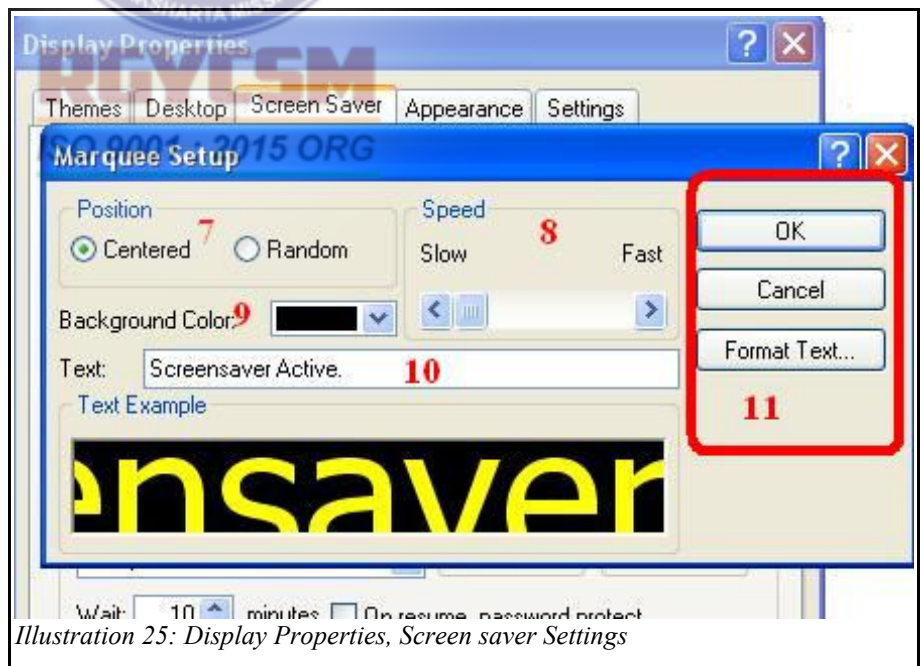


Illustration 25: Display Properties, Screen saver Settings

Display Properties, Appearance

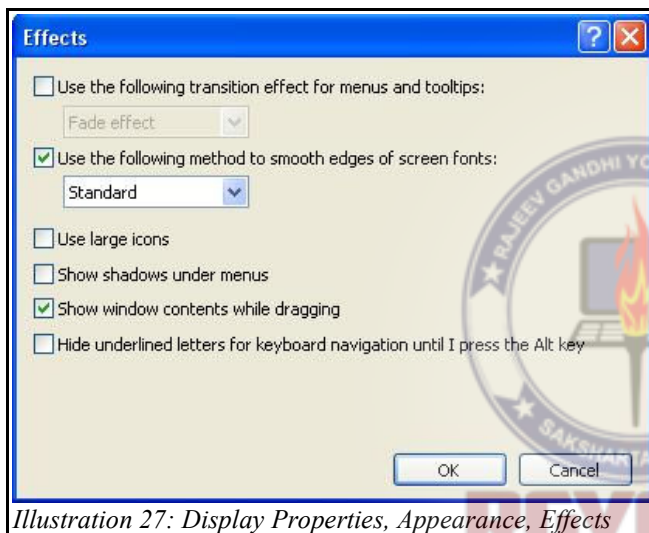


Illustration 27: Display Properties, Appearance, Effects

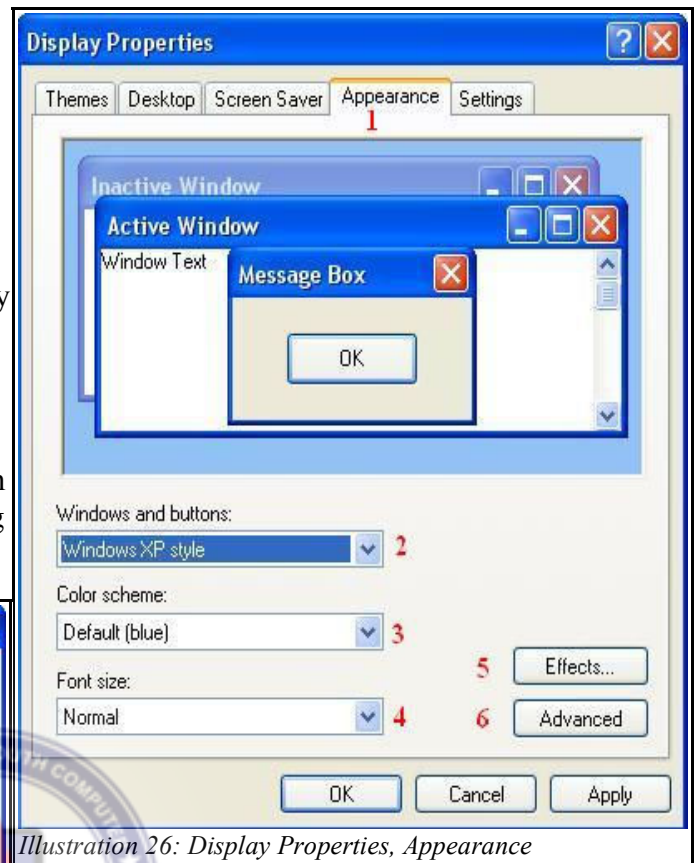


Illustration 26: Display Properties, Appearance

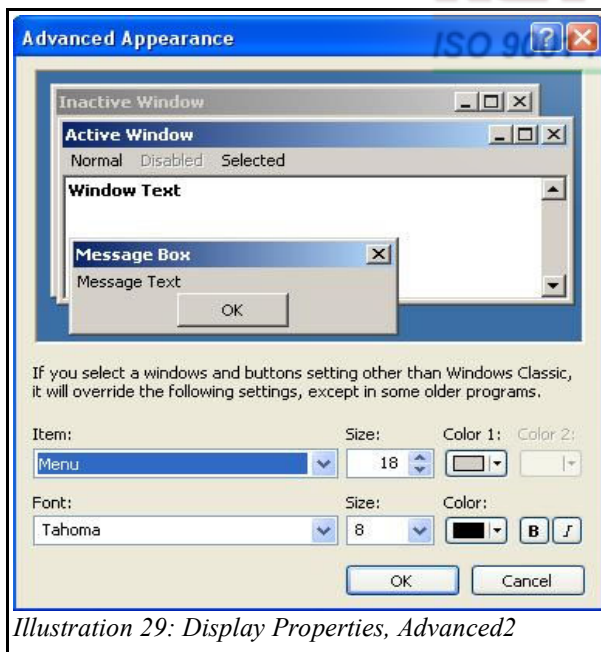


Illustration 29: Display Properties, Advanced2

Display Properties, Settings

This is probably the tab you will use most often. With it, you can change the Resolution of your screen to show more or less information at a time. The higher the resolution, the more information can be displayed on your monitor at once but the smaller everything will appear.

- 1) Select the Settings tab on the Display Properties window,
- 2) Use the **slider** in the bottom left corner to select 800 by 600 pixels,
- 3) Click on the Apply button.

One or more information boxes will open and you need to click on them before you can continue. One of them will have a count-down timer. If you do not click on it within the time allocated, it will close and restore your screen to the resolution it was prior to trying to make the change.



If you click on it in time, your screen resolution will permanently change.

How to Cut/Copy and Paste

3. If you only want to delete (Cut), you are now finished.
4. Find the new location for the text or icon.

For text:

- 4a. Click where text is to be moved to by placing the cursor there and clicking,
- 5a. Use the keyboard shortcut **Ctrl-V** to paste the cut/copied text at the cursor location.

For an icon:

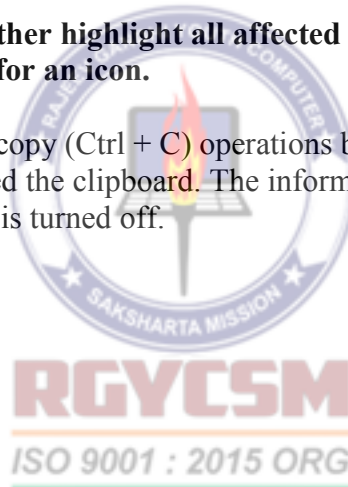
- 4b. If an icon, make sure the new location is selected in the left pane,
- 5b. **Right-Click** in a blank area of the New Locations contents in the right pane and select **Paste**.

Alternate icon paste:

- 4c. If an icon, select the New Locations contents in the right pane,
- 5c. Type the keyboard shortcut **Ctrl-V** to paste the icon to its new location.

Select - In all cases this means either highlight all affected text if referring to text or use a single left click of the mouse button for an icon.

Clipboard - the cut (Ctrl + X) and copy (Ctrl + C) operations both place the material cut or copied into a temporary area of memory called the clipboard. The information will stay there until the next cut or copy operation or the computer is turned off.

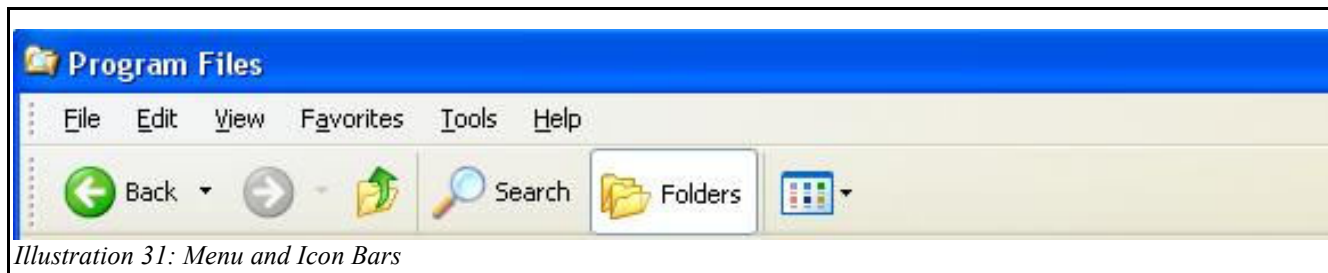


Illustration 31: Menu and Icon Bars

The Menu Bar menu names each have an underscore underneath one of the letters. Sometimes this will not show up until you press the Alt key. To access a menu without the mouse, simply hold down the Alt key and press the underlined letter.

Once a menu has been opened, you may access further menus using the arrow keys. The ► symbol at the end of a menu option indicates that there is a sub-menu present. 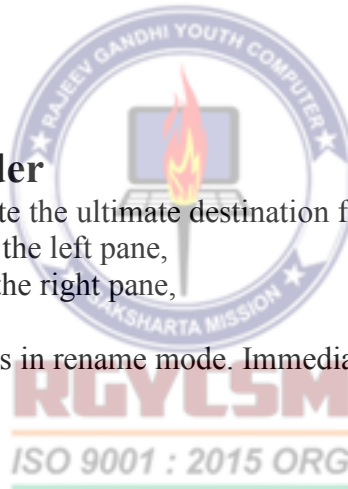

Working with Disks

A floppy disk has been the standard of storage for personal computers since 1971 when an 8-inch disk held 79KB of data. The standard, reached in 1987 for a 3½" Floppy Disk was 1.44 MB. Though storage up to 200 MB was reached by 1999 the Floppy Disk has slowly been replaced by solid-state electronic devices currently capable of storing over 16GB in a device potentially much smaller than a Pink Pearl Eraser!

Think of a mechanical computer storage device as an onion cut across the rings. You can see how the tracks (A) in the image to the right appear to be different layers in an onion. A geometrical sector (B) is then formed by two lines from the center to the outer edge. A track sector (C), or simply a Sector is where a Track and a geometrical sector intersect. This is the smallest unit of storage on a Floppy Disk. A Cluster (D) is the smallest logical amount of disk space that can be allocated to hold a file.

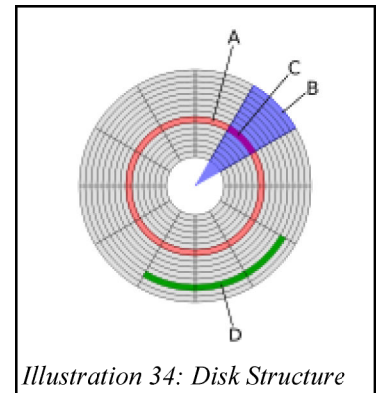


Illustration 34: Disk Structure

For a 1.44MB Floppy Disk, the Cluster is equivalent to a Sector and is 512 Bytes. 512 Bytes is approximately ½ of an 8½" x 11" sheet of single spaced, typed paper, and there are 2,847 Sectors on a 3½" Floppy Disk. It can hold an equivalent to over 1423 typed pages in ASCII format! That would be one BIG book!

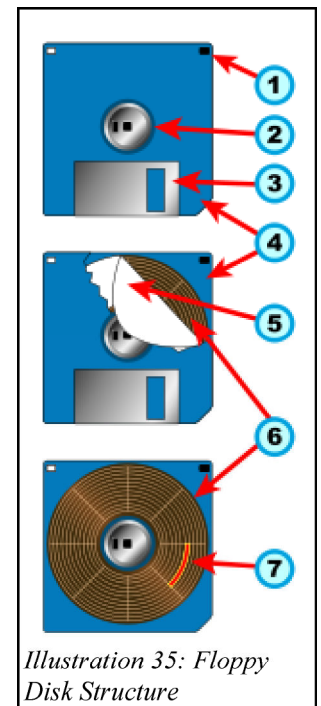
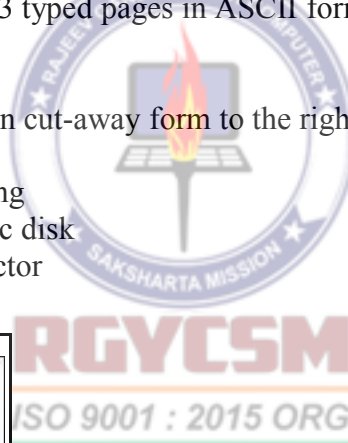


Illustration 35: Floppy Disk Structure

Disk Properties

In the first example of the Disk Properties shown on the right, the following explanation is in order:

- 1) Tabs allow for selecting different options.
Most of the time, the only additional option you will use will be Tools,
- 2) This particular disk has been given a name,
- 3) This is a Local Disk using the File System of NTFS (New Technology File System),
- 4) 295 GB storage has been used,
- 5) There is 69.6 GB of storage available,
- 6) The disk has a total capacity of 365 GB,
- 7) The pie chart gives a visual representation of used vs available space,
- 8) The Disk Cleanup button will allow for quick and easy removal of temporary files,
- 9) On newer systems Compression should almost never be needed and Indexing can sometimes drastically slow down system response,
- 10) If any changes have been made, the Apply button will be available. If it is clicked, the changes will become active and the properties window will remain open. If the OK button is clicked, the changes will become active and the properties window will close.

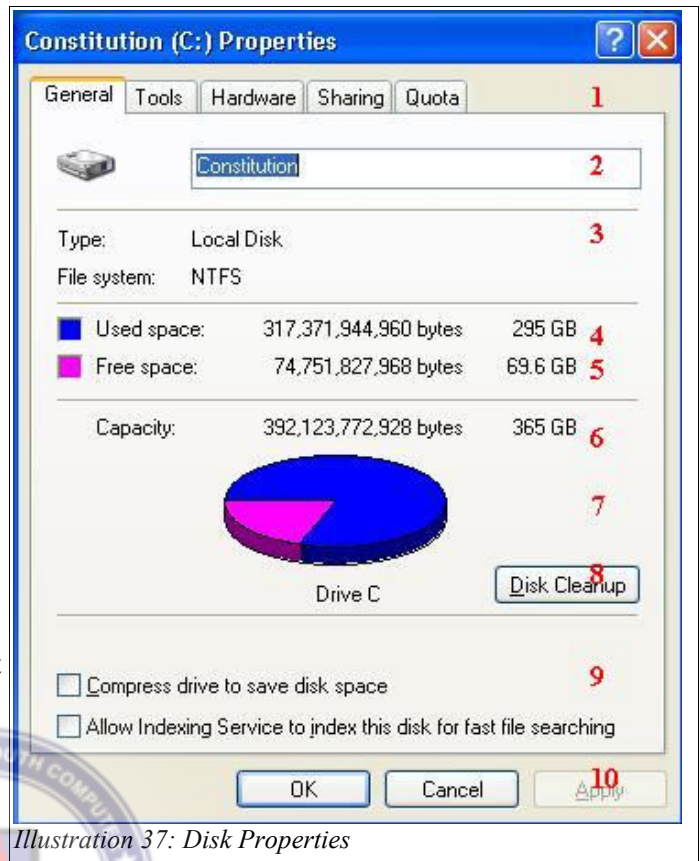


Illustration 37: Disk Properties

In the second example of Disk Properties on the right, the Tools tab is shown. You can see the three tools available with Windows XP Professional.

Working with Printers, Chapter 5

Inkjet advantages

Compared to earlier consumer-oriented color printers, inkjets have a number of advantages. They are quieter in operation than impact dot matrix or daisywheel printers. They can print finer, smoother details through higher printhead resolution, and many consumer inkjets with photographic-quality printing are widely available.

In comparison to more expensive technologies like thermal wax, dye sublimations, and laser printers, inkjets have the advantage of practically no warm up time and lower cost per page (except when compared to laser printers).

For some inkjet printers, monochrome ink sets are available either from the printer manufacturer or third-party suppliers. These allow the inkjet printer to compete with the silver-based photographic papers traditionally used in black-and-white photography, and provide the same range of tones – neutral, "warm" or "cold". When switching between full-color and monochrome ink sets, it is necessary to flush out the old ink from the print head with a special cleaning cartridge.

As opposed to most other types of printers, inkjet cartridges can be refilled. Most cartridges can be easily refilled by drilling a hole in and filling the tank portion of the cartridge. This method is more cost effective as opposed to buying a new cartridge each time one runs dry.

Inkjet disadvantages

Inkjet printers may have a number of disadvantages:

1. **The ink is often very expensive. (For a typical OEM cartridge priced at \$15, containing 5 ml of ink, the ink effectively costs \$3000 per liter--or \$8000 per gallon.)**
2. Many "intelligent" ink cartridges contain a microchip that communicates the estimated ink level to the printer; this may cause the printer to display an error message, or incorrectly inform the user that the ink cartridge is empty. In some cases, these messages can be ignored, but many inkjet printers will refuse to print with a cartridge that declares itself empty, in order to prevent consumers from refilling cartridges.
3. The lifetime of inkjet prints produced by inkjets using aqueous inks is limited; they will eventually fade and the color balance may change. On the other hand, prints produced from solvent-based inkjets may last several years before fading, even in direct sunlight, and so-called "archival inks" have been produced for use in aqueous-based machines which offer extended life.
4. Because the ink used in most consumer inkjets is water-soluble, care must be taken with inkjet-printed documents to avoid even the smallest drop of water, which can cause severe "blurring" or "running." Similarly, water-based highlighter markers can blur inkjet-printed documents, even when dry.

These disadvantages have been addressed in a variety of ways:

1. Third-party ink suppliers sell ink cartridges at significantly reduced costs (often 10%–30% of OEM cartridge prices) and also sell kits to refill cartridges, and bulk ink, at even lower prices.
2. Many vendors' "intelligent" ink cartridges have been reverse-engineered. It is now possible to buy inexpensive devices to reliably reset such cartridges to report themselves as full, so that they may be refilled many times.
3. Print lifetime is highly dependent on the quality and formulation of the ink, as well as the paper chosen. The earliest inkjet printers, intended for home and small office applications, used dye-based inks. Even the best dye-based inks are not as durable as pigment-based inks, which are now available for many inkjet printers.

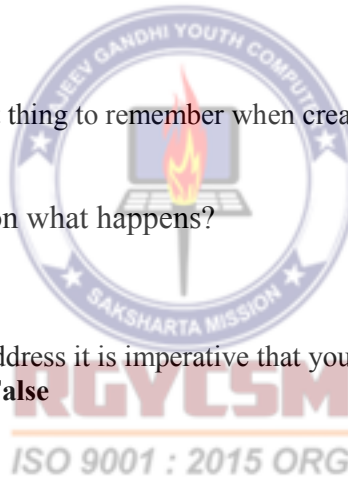

Anytime you send or receive communications on the Internet or browse a Web site, there are opportunities for individuals to intercept your communications to obtain your email address. If you post to a Usenet newsgroup, list your email address on a Web site, or fill out insecure forms on the Web, your address can be collected by Spammers, individuals who use email addresses for commercial advertising to try to gain profit for themselves and to get rich quick.

Listed below are the most important tasks that are covered in this section:

- Never open attachments unless they have been first scanned with an antivirus software program.
- Don't reply to emails requesting personal information.
- Don't buy anything from Spam email.
- Do not reply or click on links in emails or pop-up messages asking for personal information. Always go directly to the company's Web site.

Help with Spam and Phishing

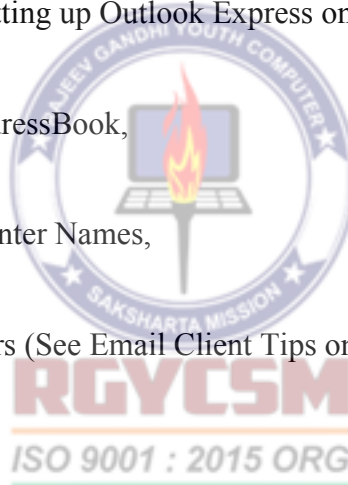
"Spam", according to various anti-spam groups (see below), is defined as "Unsolicited Commercial E-mail". That is, e-mail you didn't *ask* to be sent to you that is commercial in nature (e.g., an advertisement) -- even if it's not bulk mail sent to millions of people -- and you don't otherwise have a "prior business relationship" with the sender. Thus, "A Great Income Opportunity!" from someone you've never heard of is spam; a special offer from a site where you have an account is **not** spam, even if you aren't interested in the offer. Of course, any legitimate online retailer will stop sending you advertising mail if you ask not to receive it anymore (unlike a spammer -- more on that below), and no company should send you commercial mail unless you've gone through a "verified opt-in" process where you not only request the mail, but respond to a message sent to your address to *confirm* you really do want mail from them -- and that you actually own that address. That's what legitimate large e-mailers do. It's a reasonable and simple process for all parties.

The Internet, Netiquette

Before you ever go on the Internet and become engaged in forums, chatrooms, and Internet Commerce, you would do well to learn all you can about Netiquette. Netiquette, a combination of "network" and "etiquette", is the convention on electronic forums to facilitate efficient interaction. These rules were described in RFC (Requests For Comments) 1855. However, like many Internet phenomena, the concept and its application remain in a state of flux, and vary from community to community. The points most strongly emphasized about USENET netiquette often include avoiding cross-posting, using simple electronic signatures, and other techniques used to minimize the effort required to read a post. Netiquette guidelines posted by IBM for employees utilizing Second Life in an official capacity, however, focus on basic professionalism, maintaining a tenable work environment, and protecting IBM's intellectual property. Similarly, some Usenet guidelines call for use of unabbreviated English while users of online chat protocols like IRC and instant messaging protocols like SMS often encourage trends in the opposite direction.

For use in the PCTalk Support Forum, I am going to stress the use of proper spelling, grammar, and punctuation for all users. This is especially important since almost no one knows you personally online and the way you present yourself through the online medium is how others react to you. This is your chance to be who you want to be. Be slow to post, especially in anger, do your research before you post, and always try to be helpful. As a new Internet user, it is helpful if you realize two things:

- 1) Almost everyone you meet wants to be helpful, and
- 2) Almost anyone who has been on the Internet for any length of time has heard the same questions, put in the same way, so many times that they tend to get a bit impatient and short when they see them again.

For those who are used to the Internet, try to remember that everyone has to start somewhere and it is easier to ask simple questions than to try to find the answer when you don't know how to use the Interface. Even those who seem to know "everything" had to start somewhere!

Some "core rules" to live by:

- ★ Rule 1: Remember the Human
- ★ Rule 2: Adhere to the same standards of behavior online that you follow in real life
- ★ Rule 3: Know where you are in cyberspace
- ★ Rule 4: Respect other people's time and bandwidth
- ★ Rule 5: **Make yourself look good online**
- ★ Rule 6: Share expert knowledge
- ★ Rule 7: Help keep flame wars under control
- ★ Rule 8: Respect other people's privacy
- ★ Rule 9: Don't abuse your power
- ★ Rule 10: Be forgiving of other people's mistakes

The Internet, Security

Internet security is the prevention of unauthorized access and/or damage to computer systems via Internet access. There are many levels of protection and a multi-layered approach is safest. Here are a few things to consider:

Routers

Network Address Translation (NAT) typically has the effect of preventing connections from being established inbound into a computer, while permitting connections out. For a small home network, software NAT can be used on the computer with the Internet connection, providing similar behavior to a router and similar levels of security, but for a lower cost and lower complexity.

Firewalls

A firewall blocks all "roads and cars" through authorized ports on your computer, thus restricting unfettered access. A stateful firewall is a more secure form of firewall, and system administrators often combine a proxy firewall with a packet-filtering firewall to create a highly secure system. Most home users use a software firewall. These types of firewalls can create a log file where it records all the connection details (including connection attempts) with the PC.

Anti-virus

Some people or companies with malicious intentions write programs like computer viruses, worms, Trojan horses and spyware. These programs are all characterized as being unwanted software that install themselves on your computer through deception.

Trojan horses are simply programs that conceal their true purpose or include a hidden functionality that a user would not want.

Worms are characterized by having the ability to replicate themselves and viruses are similar except that they achieve this by adding their code onto third party software. Once a virus or worm has infected a computer, it would typically infect other programs (in the case of viruses) and other computers.

Viruses also slow down system performance and cause strange system behavior and in many cases do serious harm to computers, either as deliberate, malicious damage or as unintentional side effects.

In order to prevent damage by viruses and worms, users typically install antivirus software, which runs in the background on the computer, detecting any suspicious software and preventing it from running. Some malware that can be classified as Trojans with a limited payload are not detected by most antivirus software and may require the use of other software designed to detect other classes of malware, including spyware.

Anti-spyware

There are several kinds of threats:

- Spyware is software that runs on a computer without the explicit permission of its user. It often gathers private information from a user's computer and sends this data over the Internet back to the software manufacturer.
- Adware is software that runs on a computer without the owner's consent, much like spyware. However, instead of taking information, it typically runs in the background and displays random or targeted pop-up advertisements. In many cases, this slows the computer down and may also cause software conflicts.

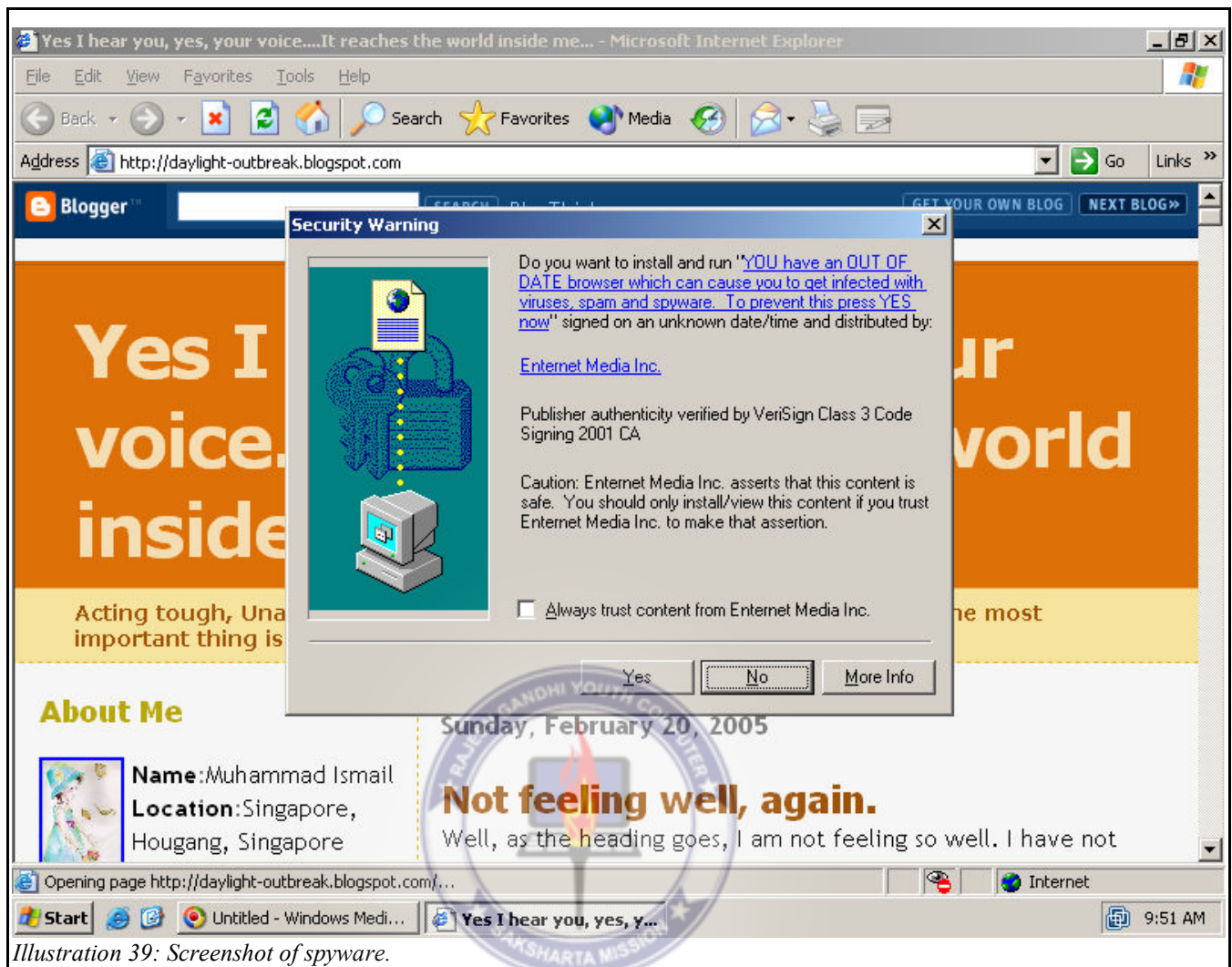


Illustration 39: Screenshot of spyware.

Keeping yourself and your kids safe on social networks

The quick tips for teens:

- Put everything behind password protected walls, where only friends can see
- Protect your password and make sure you really know who someone is before you allow them onto your friends list
- Blur or morph your photos a bit so they won't be abused by cyberbullies or predators
- Don't post anything your parents, principal or a predator couldn't see
- What you post online stays online - forever!!!! So thinkb4uClick!
- Don't do or say anything online you wouldn't say offline
- Protect your privacy and your friends' privacy too...get their okay before posting something about them or their picture online
- Check what your friends are posting/saying about you. Even if you are careful, they may not be and may be putting you at risk.
- That cute 14-year old boy may not be cute, may not be 14 and may not be a boy! You never know!
- And, unless you're prepared to attach your MySpace to your college/job/internship/scholarship or sports team application...don't post it publicly!

And for parents:

- Talk to your kids – ask questions (and then confirm to make sure they are telling you the truth!)
- Ask to see their profile page (for the first time)...tomorrow! (It gives them a chance to remove everything that isn't appropriate or safe...and it becomes a way to teach them what not to post instead of being a gotcha moment! Think of it as the loud announcement before walking downstairs to a teen party you're hosting.)
- Don't panic...there are ways of keeping your kids safe online. It's easier than you think!
- Be involved and work with others in your community. (Think about joining WiredSafety.org and help create a local cyber-neighborhood watch program in your community.)
- Remember what you did that your parents would have killed you had they known, when you were fifteen.
- This too will pass! Most kids really do use social networks just to communicate with their friends. Take a breath, gather your thoughts and get help when you need it. (You can reach out to WiredSafety.org.)
- It's not an invasion of their privacy if strangers can see it. There is a difference between reading their paper diary that is tucked away in their sock drawer...and reading their MySpace. One is between them and the paper it's written on; the other between them and 700 million people online!
- Don't believe everything you read online – especially if your teen posts it on her MySpace!
- And, finally....repeat after me – “I'm still the parent!” If they don't listen or follow your rules, unplug the computer...the walk to the library will do them good. ☺

Display Resolution Discussion

The display resolution of a digital television or computer display typically refers to the number of distinct pixels in each dimension that can be displayed. It can be an ambiguous term especially as the displayed resolution is controlled by all different factors in cathode ray tube (CRT) and flat panel or projection displays using fixed picture-element (pixel) arrays.

One use of the term "display resolution" applies to fixed-pixel-array displays such as plasma display panels (PDP), liquid crystal displays (LCD), or similar technologies, and is simply the physical number of columns and rows of pixels creating the display (e.g., 1280×1024). A consequence of having a fixed grid display is that for multi-format video inputs all displays need a "scaling-engine" (a digital video processor that includes a memory array) to match the incoming picture format to the display.

Note that the use of the word resolution here is misleading. The term "display resolution" is usually used to mean pixel dimensions (e.g., 1280×1024), which does not tell you anything about the resolution of the display on which the image is actually formed (which would typically be given in pixels per inch (digital) or number of lines measured horizontally, per picture height (analog)).

Considerations

Some commentators also use the term, "display resolution", to indicate a range of input formats that the displays input electronics will accept and often include formats greater than the screen's native grid size even though they have to be down-scaled to match the screen's parameters (e.g., accepting a 1920×1080 input on a display with a native 1366×768 pixel array). In the case of television inputs, many manufacturers will take the input and zoom it out to "overscan" the display by as much as 5% so input resolution is not necessarily display resolution.

The eye's perception of "display resolution" can be affected by a number of factors. One factor is the display screen's rectangular shape, which is expressed as the ratio of the physical picture width to the picture height. This is known as the aspect ratio. A screen's physical aspect ratio and the individual pixels' aspect ratio may not necessarily be the same. An array of 1280×720 on a 16:9 display has square pixels. An array of 1024×768 on a 16:9 display has rectangular pixels.

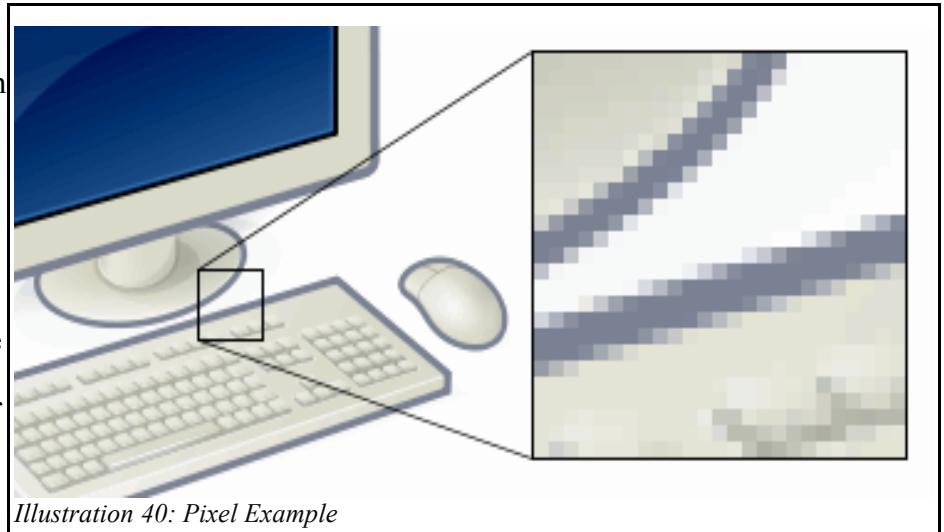
An example of pixel shape affecting "resolution" or perceived sharpness: displaying more information in a smaller area using a higher resolution makes the image much clearer. However, newer LCD displays and such are fixed at a certain resolution; making the resolution lower on these kinds of screens will greatly decrease sharpness, as an interpolation process is used to "fix" the non-native resolution input into the displays native resolution output.

While some CRT (Cathode Ray Tube, a big vacuum tube) based displays may use digital video processing that involves image scaling using memory arrays, ultimately "display resolution" in CRT-type displays is affected by different parameters such as spot size and focus, astigmatic effects in the display corners, the color phosphor pitch shadow mask (such as Trinitron) in color displays, and the video bandwidth.

Pixels

In digital imaging, a pixel (picture element) is the smallest piece of information in an image. Pixels are normally arranged in a regular 2-dimensional grid, and are often represented using dots or squares. Each pixel is a sample of an original image, where more samples typically provide a more accurate representation of the original. The intensity of each pixel is variable; in color systems, each pixel has typically three or four components such as red, green, and blue, or cyan, magenta, yellow, and black.



The word pixel is based on a contraction of pix (for "pictures") and el (for "element").

Technical



A pixel is generally thought of as the smallest single component of an image. The definition is highly context sensitive; for example, we can speak of printed pixels in a page, or pixels carried by electronic signals, or represented by digital values, or pixels on a display device, or pixels in a digital camera (photosensor elements). This list is not exhaustive, and depending on context there are several terms that are synonymous in particular contexts, e.g. pel, sample, Byte, BIT, dot, spot, etc. We can also speak of pixels in the abstract, or as a unit of measure, in particular when using pixels as a measure of resolution, e.g. 2400 pixels per inch, 640 pixels per line, or spaced 10 pixels apart.

Dot Pitch

Dot pitch (sometimes called line pitch, phosphor pitch or pixel pitch) is a specification for a computer display, computer printer, image scanner or other pixel-based device that describes the distance, for example, between dots (sub-pixels) of the same color on the inside of a display screen. In the case of a color display dot pitch is a measure of the size of a triad plus the distance between the triads.

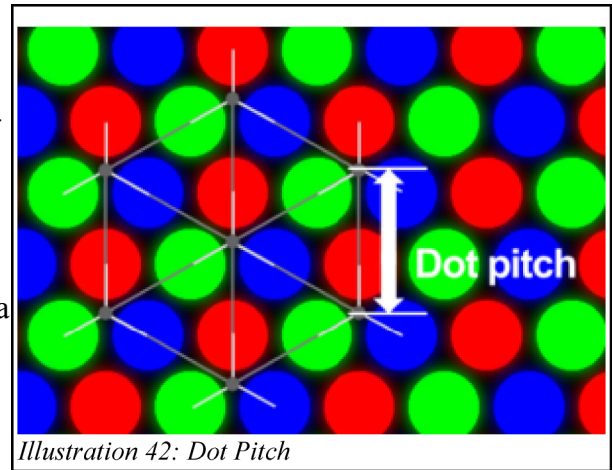


Illustration 42: Dot Pitch

Dot pitch may be measured in linear units, usually millimeters, with a smaller number meaning closer spacing, or in dots per linear unit, for example dots per inch, with a larger number meaning wider spacing. Closer spacing generally produces a sharper image (as there are more pixels in a given area). However, other factors may affect image quality, including:

- measurement method not documented, complicated by general ignorance of the existence of multiple methods
- pixel spacing varying across screen area (e.g., increasing in corners compared to center)
- differing pixel geometries
- differing screen resolutions when attempting to judge picture quality
- tightness of electron beam focus and aim (in CRTs)
- differing aspect ratios

Traditionally, dot pitch in displays has been measured on the diagonal, as this gives the most accurate representation of image quality. Starting about the mid-1990s, however, some companies introduced a horizontal dot pitch as a marketing ploy. By measuring only the horizontal component of the dot pitch and ignoring the vertical component, even a cheap, low-quality monitor could be awarded a small-seeming dot pitch.

The exact difference between horizontal and diagonal dot pitch varies with the design of the monitor, but a typical entry-level 0.28 mm (diagonal) monitor has a horizontal pitch of 0.24 or 0.25 mm, a good quality 0.26 mm (diagonal) unit has a horizontal pitch of 0.22 mm. The smallest dot pitch at the current time is 0.099 mm.

The above dot pitch measurement do not apply to aperture grille displays. Such monitors use continuous vertical phosphors band on the screen, so the vertical distance between scan lines is limited only by video input signal's vertical resolution and the thickness of electron beam, so there is no vertical 'dot pitch' on such devices. Aperture grille only has horizontal 'dot pitch', or otherwise known as 'stripe pitch'.

File Extensions

A filename extension is a suffix to the name of a computer file applied to indicate the encoding convention of its contents, i.e. the file format. In some operating systems (for example Unix) it is a convention, while in some others it is a requirement. Some operating systems limit the length of the extension (such as DOS and OS/2, to three characters) while others (such as Unix) do not.

When discussing file names and extensions in class the following general format will be used:

<filename>.<extension>,

where

<filename> is replaced by the name of the file,

the name of the file and its extension are separated by a required dot or period, and

<extension> is the File Extension of the program or data file.

In DOS and early Windows systems, the <filename> was limited to 8 characters and the <extension> was limited to 3, leading to the shorthand of 8.3 to indicate the file naming conventions. Newer versions of Windows use long file names and are not limited to 8 or 3.

How does Windows know what to do when you click on an Icon?

There are only two types of files under Windows, Program Files and Data Files. A Program File (Program under common usage) is a file that can be run by itself and performs actions on data files of specific types. Windows maintains a table on disk that can be thought of as consisting of two columns; a column containing the file extension, listed alphabetically, and a list of the program file that will be used to modify a data file with that type of extension.

There are currently only three File Extensions that denote Programs that we will be concerned with in this class. **Program File** extensions are:

1. .com - **COM**iled file. This is the earliest type of program and was designed using a limited memory model, so it can only directly address a small amount of memory, typically 1 MB or less,
2. .bat - **BAT**ch file. This is simply an ASCII text file with the file extension changed. It emulates the card batch process on old mainframe computers. One line of the file at a time is read, interpreted, and executed before the next line is parsed, and
3. .exe - **EXE**cutable file. This type of program started being used when available memory in computers went over the 1 MB mark. It uses indirect addressing.

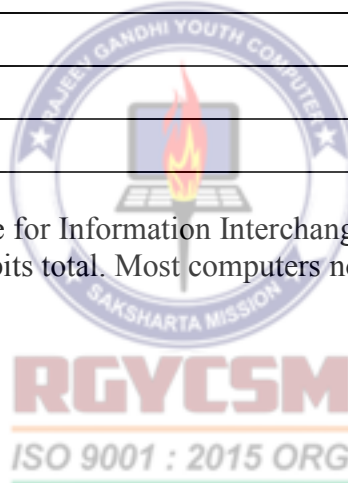
Data File extensions, on the other hand, are legion. Considering that there are currently 5 (or more!) spaces available for a file extension and assuming 40 possible characters for each position (a-z, 0-9, plus at least 4 other symbols) then the total number of possible file extensions is on the order of 40^5 or 102,400,000 (minus 3) different File Extensions possible for Data Files!

Because of the reference table mentioned above, when you double-click on a data file with a txt extension, it knows by default to use the program file Notepad.exe to modify the data file.

The following table gives some of the more common data file extensions (**not** listed alphabetically), the program file used for modification by default, and some comments:

Ext	Default Program	Comments
txt	Notepad.exe	Denotes a pure *ASCII text file, zero bytes of overhead but no formatting.
doc	Word.exe OpenOffice.exe	Denotes an OpenOffice or Microsoft Word document, thousands of bytes overhead but multiple text formatting options are available.
wpd	WordPerfect.exe	Denotes a Corel Word Perfect document. Similar to MS Word.
wpg	WordPerfect.exe	Denotes a Corel Word Perfect graphics file.
bmp	Paint.exe	Denotes a Bit Mapped Picture file
jpeg	various	Denotes a compressed graphics file (Joint Photographic Experts Group).
html htm	Internet Explorer, Firefox, etc.	Denotes a Hypertext Markup Language file used to display web pages.
rtf	Wordpad.exe	Denotes a Rich Text Format. This is somewhere between the ASCII of notepad and the format rich environment of Word. There is a formatting overhead involved but not as much as for a full Word document.

*ASCII - American Standard Code for Information Interchange. There are only 128 characters defined in the basic character set, using 7 bits total. Most computers now use an 8 bit extended character set that defines 256 ASCII characters.



Database Design

We have the free OpenOffice integrated package installed on the computers in this class, so will be using the OpenOffice Base program to design and create an address book database. Please be very careful to follow all instructions exactly when you create your database as we want to make them interchangeable with all others. That means spelling and even capitalization must match from one student's database to another's.

During class, I will be talking you through all the required steps but thought I would provide this document as an addendum so I could save some time in laying out the **database** and to try to normalize the results for all students.

Definitions:

Field – this is a single, discrete piece of information. A last name, a phone number, and a zip code are all fields.

Record – this is all the information about a single, unique entity. In this case, it is all information about a single person in our **addressbook database**. A **record** is composed of **fields** of information.

Database – this has two definitions:

- 1) The program used to create and maintain records of information, and
- 2) A group of **records** as defined above. Therefore, we are going to create an AddressBook database using a **database** program. Notice I have combined the word address and book into a single word. This is the name we will use to save the **database**.

Step 1:

In designing a **database** you should always start with pencil and paper. Write down all the **fields** you think you will want and as much information as you think you will need to get the results you want. In our case, we are going to use this **addressbook** later with our exercise in mail merge, so there are certain **fields** we will definitely want to have. Below is a list of each field along with all the information associated with it for an example AddressBook. We will not be using this data because OpenOffice has a much simpler way to create the fields as you will soon see.

Step 2:

Run the **database program** and create your **database template** using the data as given in the second page of this handout.

Step 3:

Populate your **database**. This means you simply add the information you want to store into the **database**. Don't forget to **SAVE OFTEN!** A good time to save would be after entering each **Record** into the **database**. Use the name AddressBook as the name to save under and your named folder as the place to save. Please note that both the "A" and the "B" are capitalized and there is no space between "Address" and "Book".

Creating a database

Step 1:

- a. Run OpenOffice Base from the Programs menu, a database Wizard window will open with the option **1. Select database** highlighted under Steps. You want to Create a new database, which is already selected, so click on **Next**.
- b. Now, **2. Save and proceed** is highlighted under Steps. We will accept all the defaults as well as checking Create tables using the table wizard and then click on **Finish** at the bottom.
- c. A new window titled **Save As** will open with the folders of My Documents displayed. Navigate to your named folder and type in **AddressBook** in the File name and press **Enter**, which will save the empty database form and open it in the OpenOffice Base program.
- d. A Table Wizard window will also open. For **Category**, select **Personal**. Under **Sample tables**, select **Addresses**. Select the following fields and move them over to the right in the same order as listed:
 1. AddressID
 2. Title
 3. LastName
 4. FirstName
 5. Address
 6. City
 7. StateOrProvince
 8. PostalCode
 9. CountryOrRegion
 10. PhoneNumber
 11. Notes
 12. DateUpdated
- e. Click on **Next**,
- f. Under "Set types and formats, make AddressID AutoValue Yes and make LastName, FirstName, and PostalCode all a required Entry,
- g. Click on **Next**,
- h. Under Set primary key, make sure Create a primary key is unchecked,
- i. Click on **Next**,
- j. Under Create table: What do you want to do next, ensure Create a form based on this table is selected,
- k. Click on **Finish**.

Creating a data entry form

Step 2:

- a. OpenOffice Writer is now opened as well as another Form Wizard containing all the fields so far selected. Under Field selection, move all fields over to the right and move AddressID back to the left,
- b. Click on **Next**,
- c. Click on **Next**,
- d. Under Arrange controls: arrangement of the main form; select whichever looks best to you. I selected the one on the far right,
- e. Click on **Next**,
- f. Click on **Next**,
- g. Under Apply styles, select whatever you wish. I left it as is,
- h. Click on **Next**,
- i. Under Name of the form, enter **Address Entry**,
- j. Click on **Finish**.

Mail Merge

With the OpenOffice integrated package we will be using the Writer Word Processor program to design and create a mail merge document. Please be very careful to follow all instructions exactly when you create your document as we want to make them interchangeable with all others. Again, I thought I would provide this document as an addendum so I could save some time in laying out the **mail merge document** and to try to normalize the results across all students. We will be creating a simple business letter with very few fields but it will be enough to show you that much more complex mail merge is possible.

Create the **FROM** Address Block:

1. Click on the Align Right Icon in the Icon Bar,
2. Type in the following address pressing the Enter key everywhere there is a semi-colon: Internet 123, Inc.; 50572 Jefferson; New Baltimore, MI 48047; USA
3. **Note:** The above is an actual Spammer's information according to the Spamhaus Project at <http://www.spamhaus.org/>
4. Press the Enter key and select the Align Left icon in the Icon Bar,
5. Press the Enter key again so there will be two lines between the From and the To address,
6. Click on File\Save As and navigate to your named folder. Use **MMLetter** as the name of the file to save,

Create the **TO** Address Block:

1. Open OpenOffice Write,
2. Select Insert\Fields\Other and a Fields window will open,
3. Select Mail merge fields on the left and AddressBook on the right,
4. Open AddressBook by clicking on the +,
5. Open Addresses by clicking on the +,
6. Select Title and click on Insert. The Mail Merge variable for <Title> will show up in the OpenOffice Write window,
7. Click in the Writer window and press the spacebar,
8. Select FirstName from the Fields list and click on Insert. The Mail Merge variable for <FirstName> will show up in the OpenOffice Write window. Click in the Writer window and press the spacebar,
9. Select LastName from the Fields list and click on Insert. The Mail Merge variable for <LastName> will show up in the OpenOffice Write window. Click in the Writer window and press the Enter key to move to the next line,
10. Select Address from the Fields list and click on Insert. The Mail Merge variable for <Address> will show up in the OpenOffice Write window. Click in the Writer window and press the Enter key to move to the next line,
11. Select City and click on Insert. The Mail Merge variable for <City> will show up in the OpenOffice Write window. Click in the Writer window and press a comma and the spacebar,
12. Select StateOrProvince and click on Insert. The Mail Merge variable for <StateOrProvince> will show up in the OpenOffice Write window. Click in the Writer window and press the spacebar twice,
13. Select PostalCode from the Fields list and click on Insert. The Mail Merge variable for <PostalCode> will show up in the OpenOffice Write window. Click in the Writer window and press the Enter key to move to the next line,
14. Select CountryOr Region and click on Insert. The Mail Merge variable for <CountryOr Region> will show up in the OpenOffice Write window. Click in the Writer window and press the Enter key twice to open up a blank line below the Address you've just inserted,
15. Save your document,

Create the **BODY** of your Mail Merge letter:

1. Type Dear, press the spacebar,
2. Select Title in the Fields window, and click on Insert. The Mail Merge variable for <Title> will show up in the OpenOffice Write window. Click in the Writer window and press the spacebar,
3. Select LastName in the Fields window, and click on Insert. The Mail Merge variable for <LastName> will show up in the OpenOffice Write window. Click in the Writer window and press the comma followed by the Enter key,
4. Type in the following paragraph: "**This letter is to inform you that your information has been used in a mail merge document for hundreds of illegal and immoral purposes. You have won no prizes, nor have you been entered into any contests.**". Press the Enter key twice,
5. Type in the following paragraph: "**We do have a notes field stored with your other information. Its contents are:**",
6. Select Notes in the Fields window, and click on Insert. The Mail Merge variable for <Notes> will show up in the OpenOffice Write window. Press the Enter key twice,
7. Type in the following: "**This data was updated:**". Press the spacebar,
8. Select DateUpdated in the Fields window, and click on Insert. The Mail Merge variable for <DateUpdated> will show up in the OpenOffice Write window. Press the Enter key twice.

Create the **CLOSING** of your Mail Merge letter:

1. Type "Sincerely," and press the Enter key 6 times,
2. Type in "I. M. Annoying" and press the Enter key,
3. Type in "CEO, Big Bucks Telemarketers" and save your Mail Merge letter one last time.

Printing your Mail Merge document:

1. Open the saved Mail Merge document,
2. Click on File\Print,
3. A window opens stating, "Your document contains address fields. Do you want to print a form letter?" Click on Yes,
4. A mail Merge window opens with the database fields visible. For Output, select File,
5. For Save merged document, select "Save as individual document",
6. Tick "Generate file name from Database",
7. Set Field to LastName,
8. Set Path to your named folder,
9. Click on OK.

All letters will be created as files and saved into your named folder for printing later if you wish. We are doing this simply because our network is not working and the printer is not connected to any of the computers. If you were doing this from home, you would probably send the output directly to the printer. If you do, make sure there is enough ink and paper for all the letters to be printed before you start.

Here is a sample letter to use when creating your Mail Merge Document:

Spreadsheet Demo

We will be using the OpenOffice Calc program to demo two simple spreadsheets. All required files are in the My Documents\Class Basic\Exercises folder on your computer. Double-click on a spreadsheet template to open it in the Calc (Spreadsheet) program.

A spreadsheet may be considered to be a cross between an electronic calculator and a whiteboard. When you look at a blank spreadsheet template you will see a blank area composed of rows and columns. Each column has an alphabetic designation and each row has a numeric designation. Each block where a specific numbered row crosses a specific lettered column is called a **cell**. A cell may hold a number, an equation, or text. Each cell may also have multiple attributes, such as color, height, width, type, etc.

You can use F9 to force recalculation and, in some cases, may have to press it multiple times so all calculations can be performed.

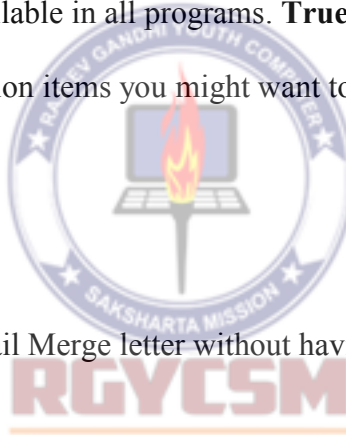

If you go to cell L371 you will see that, over a period of 30 years using the Base Loan data you will have repaid a total of \$231,715.07 for the privilege of borrowing \$80,000.00!

If you look closely, you will see that the last payment will be on June 2034 and that the interest paid is \$151,715.07 or almost 153% more than just the cost of the house!

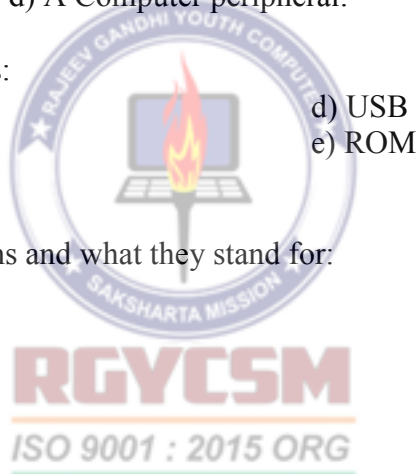

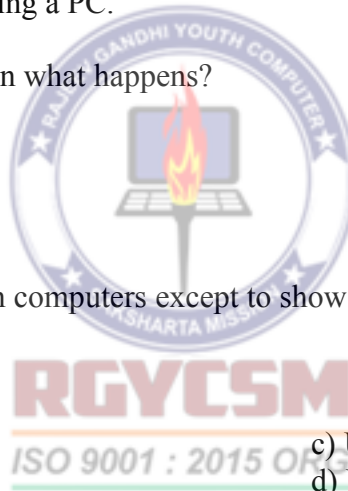

Definitions:

ASCII - American Standard Code for Information Interchange. There are only 128 characters defined in the basic character set, using 7 bits total. Most computers now use Unicode, an 8 bit extended character set that defines 256 discrete characters. <http://en.wikipedia.org/wiki/Ascii>

BIT - a single **binary digit**, a logical one or zero.

BMP - file format, sometimes called bitmap or DIB file format (for device-independent bitmap), is an image file format used to store bitmap digital images, especially on Microsoft Windows and OS/2 operating systems. In uncompressed BMP files, and many other bitmap file formats, image pixels are stored with a color depth of 1, 4, 8, 16, 24, or 32 bits per pixel. Images of 8 bits and fewer can be either grayscale or indexed color. An alpha channel (for transparency) may be stored in a separate file, where it is similar to a grayscale image, or in a fourth channel that converts 24-bit images to 32 bits per pixel. Uncompressed bitmap files (such as BMP) are typically much larger than compressed (with any of various methods) image file formats for the same image. For example, the 1058×1058 Wikipedia logo, which occupies about 287.65 KB in the PNG format, takes about 3358 KB as a 24-bit BMP file. Uncompressed formats are generally unsuitable for transferring images on the Internet or other slow or capacity-limited media.

Byte - 8 BITS, a single character, one of 256 possible characters in the ASCII character set.

DOC - (an abbreviation of 'document') is a file extension for word processing documents; most commonly for Microsoft Word. Historically, the extension was used for documentation in plain-text format, particularly of programs or computer hardware, on a wide range of operating systems. During the 1980s, WordPerfect used DOC as the extension of their proprietary format. Later, in the 1990s, Microsoft chose to use the DOC extension for their proprietary Microsoft Word word processing formats. The original uses for the extension have largely disappeared from the PC world. Binary DOC files often contain more text formatting information (as well as scripts and undo information) than files using other document file formats like Rich Text Format and HyperText Markup Language, but are usually less widely compatible. HTML - (**HTM** also used) an initialism of HyperText Markup Language, is the predominant markup language for web pages. It provides a means to describe the structure of text-based information in a document — by denoting certain text as links, headings, paragraphs, lists, and so on — and to supplement that text with interactive forms, embedded images, and other objects. HTML is written in the form of tags, surrounded by angle brackets. HTML can also describe, to some degree, the appearance and semantics of a document, and can include embedded scripting language code (such as JavaScript) which can affect the behavior of Web browsers and other HTML processors. The form HTM is also used. <http://en.wikipedia.org/wiki/HTML>

JPEG - In computing, JPEG (pronounced JAY-peg) is a commonly used method of compression for photographic images. The name JPEG stands for Joint Photographic Experts Group, the name of the committee that created the standard. The group was organized in 1986, issuing a standard in 1992, which was approved in 1994 as ISO 10918-1. JPEG is distinct from MPEG (Moving Picture Experts Group), which produces compression schemes for video. Sometimes referred to as JPG.

MPEG - The Moving Picture Experts Group, commonly referred to as simply MPEG, is a working group of ISO/IEC charged with the development of video and audio encoding standards. Its first meeting was in May of 1988 in Ottawa, Canada. As of late 2005, MPEG has grown to include approximately 350 members per meeting from various industries, universities, and research institutions. MPEG's official designation is ISO/IEC JTC1/SC29 WG11.

MPEG has standardized the following compression formats and ancillary standards:

- MPEG-1: Initial video and audio compression standard. Later used as the standard for Video CD, and includes the popular Layer 3 (MP3) audio compression format.
- MPEG-2: Transport, video and audio standards for broadcast-quality television. Used for over-the-air digital television ATSC, DVB and ISDB, digital satellite TV services like Dish Network, digital cable television signals, SVCD, and with slight modifications, as the .VOB (Video Object) files that carry the images on DVDs.
- MPEG-3: Originally designed for HDTV, but abandoned when it was realized that MPEG-2 (with extensions) was sufficient for HDTV. (not to be confused with MP3, which is MPEG-1 Audio Layer 3.)
- MPEG-4: Expands MPEG-1 to support video/audio "objects", 3D content, low bitrate encoding and support for Digital Rights Management. Several new higher efficiency video standards (newer than MPEG-2 Video) are included (an alternative to MPEG-2 Video), notably:
 - ➔ MPEG-4 Part 2 (or Advanced Simple Profile) and
 - ➔ MPEG-4 Part 10 (or Advanced Video Coding or H.264). MPEG-4 Part 10 may be used on HD DVD and Blu-ray discs, along with VC-1 and MPEG-2.

In addition, the following standards, while not sequential advances to the video encoding standard as with MPEG-1 through MPEG-4, are referred to by similar notation:

- MPEG-7: A multimedia content description standard.
- MPEG-21: A multimedia framework.

RTF - Rich Text Format (often abbreviated RTF) is a free document file format developed by Microsoft in 1987 for cross-platform document interchange. Most word processors are able to read and write RTF documents. Members of the Microsoft Word development team developed the original RTF in the middle to late 1980s. The first RTF reader and writer shipped in 1987 as part of Microsoft Word 3.0 for Macintosh, which implemented the version 1.0 RTF specification. All subsequent releases of Microsoft Word for the Macintosh and all versions of Microsoft Word for Windows have included built-in RTF readers and writers which translate from RTF to Word's .doc format and from .doc to RTF. The standard is still owned by Microsoft to this date; as of March 2008 it is up to version 1.9.1 http://en.wikipedia.org/wiki/Rich_Text_Format

TXT - a filename extension for files consisting of text usually contain very little formatting (ex: no bolding or italics). The precise definition of the .txt format is not specified, but typically matches the format accepted by the system terminal or simple text editor. Files with the .txt extension can easily be read or opened by any program that reads text and, for that reason, are considered universal (or platform independent). The ASCII character set is the most common format for English-language text files, and is generally assumed to be the default file format in many situations. For accented and other non-ASCII characters, it is necessary to choose a character

encoding. In many systems, this is chosen on the basis of the default locale setting on the computer it is read on. Common character encodings include ISO 8859-1 for many European languages.

Netiquette Guidelines

Status of This Memo

This memo provides information for the Internet community. This memo does not specify an Internet standard of any kind. Distribution of this memo is unlimited.

Abstract

This document provides a minimum set of guidelines for Network Etiquette (Netiquette) which organizations may take and adapt for their own use. As such, it is deliberately written in a bulleted format to make adaptation easier and to make any particular item easy (or easier) to find. It also functions as a minimum set of guidelines for individuals, both users and administrators. This memo is the product of the Responsible Use of the Network (RUN) Working Group of the IETF.

1.0 Introduction

In the past, the population of people using the Internet had "grown up" with the Internet, were technically minded, and understood the nature of the transport and the protocols. Today, the community of Internet users includes people who are new to the environment. These "Newbies" are unfamiliar with the culture and don't need to know about transport and protocols. In order to bring these new users into the Internet culture quickly, this Guide offers a minimum set of behaviors which organizations and individuals may take and adapt for their own use. Individuals should be aware that no matter who supplies their Internet access, be it an Internet Service Provider through a private account, or a student account at a University, or an account through a corporation, that those organizations have regulations about ownership of mail and files, about what is proper to post or send, and how to present yourself. Be sure to check with the local authority for specific guidelines.

We've organized this material into three sections: One-to-one communication, which includes mail and talk; One-to-many communications, which includes mailing lists and NetNews; and Information Services, which includes ftp, WWW, Wais, Gopher, MUDs and MOOs. Finally, we have a Selected Bibliography, which may be used for reference.

2.0 One-to-One Communication electronic mail, talk

We define one-to-one communications as those in which a person is communicating with another person as if face-to-face: a dialog. In general, rules of common courtesy for interaction with people should be in force for any situation and on the Internet it's doubly important where, for example, body language and tone of voice must be inferred. For more information on Netiquette for communicating via electronic mail and talk, check references [1,23,25,27] in the Selected Bibliography.

2.1 User Guidelines

2.1.1 For mail:

- Unless you have your own Internet access through an Internet provider, be sure to check with your employer about ownership of electronic mail. Laws about the ownership of electronic mail vary from place to place.
- Unless you are using an encryption device (hardware or software), you should assume that mail on the Internet is not secure. Never put in a mail message anything you would not put on a postcard.
- Respect the copyright on material that you reproduce. Almost every country has copyright laws.
- If you are forwarding or re-posting a message you've received, do not change the wording. If the message was a personal message to you and you are re-posting to a group, you should ask permission first. You may shorten the message and quote only relevant parts, but be sure you give proper attribution.
- Never send chain letters via electronic mail. Chain letters are forbidden on the Internet. Your network privileges will be revoked. Notify your local system administrator

if you ever receive one.

- A good rule of thumb: Be conservative in what you send and liberal in what you receive. You should not send heated messages (we call these "flames") even if you are provoked. On the other hand, you shouldn't be surprised if you get flamed and it's prudent not to respond to flames.
- In general, it's a good idea to at least check all your mail subjects before responding to a message. Sometimes a person who asks you for help (or clarification) will send another message which effectively says "Never Mind". Also make sure that any message you respond to was directed to you. You might be cc:ed rather than the primary recipient.
- Make things easy for the recipient. Many mailers strip header information which includes your return address. In order to ensure that people know who you are, be sure to include a line or two at the end of your message with contact information. You can create this file ahead of time and add it to the end of your messages. (Some mailers do this automatically.) In Internet parlance, this is known as a ".sig" or "signature" file. Your .sig file takes the place of your business card. (And you can have more than one to apply in different circumstances.)
- Be careful when addressing mail. There are addresses which may go to a group but the address looks like it is just one person. Know to whom you are sending.
- Watch cc's when replying. Don't continue to include people if the messages have become a 2-way conversation.
- In general, most people who use the Internet don't have time to answer general questions about the Internet and its workings. Don't send unsolicited mail asking for information to people whose names you might have seen in RFCs or on mailing lists.
- Remember that people with whom you communicate are located across the globe. If you send a message to which you want an immediate response, the person receiving it might be at home asleep when it arrives. Give them a chance to wake up, come to work, and login before assuming the mail didn't arrive or that they don't care.

- Verify all addresses before initiating long or personal discourse. It's also a good practice to include the word "Long" in the subject header so the recipient knows the message will take time to read and respond to. Over 100 lines is considered "long".
- Know whom to contact for help. Usually you will have resources close at hand. Check locally for people who can help you with software and system problems. Also, know whom to go to if you receive anything questionable or illegal. Most sites also have "Postmaster" aliased to a knowledgeable user, so you can send mail to this address to get help with mail.
- Remember that the recipient is a human being whose culture, language, and humor have different points of reference from your own. Remember that date formats, measurements, and idioms may not travel well. Be especially careful with sarcasm.
- Use mixed case. UPPER CASE LOOKS AS IF YOU'RE SHOUTING.
- Use symbols for emphasis. That **is** what I meant. Use underscores for underlining. _War and Peace_ is my favorite book.
- Use smileys to indicate tone of voice, but use them sparingly. :-) is an example of a smiley (Look sideways). Don't assume that the inclusion of a smiley will make the recipient happy with what you say or wipe out an otherwise insulting comment.
- Wait overnight to send emotional responses to messages. If you have really strong feelings about a subject, indicate it via FLAME ON/OFF enclosures. For example:
- FLAME ON: This type of argument is not worth the bandwidth it takes to send it. It's illogical and poorly reasoned. The rest of the world agrees with me. FLAME OFF
- Do not include control characters or non-ASCII attachments in messages unless they are MIME attachments or unless your mailer encodes these. If you send encoded messages make sure the recipient can decode them.
- Be brief without being overly terse. When replying to a message, include enough original material to be understood but no more. It is extremely bad form to simply reply to a message by including all the previous message: edit out all the irrelevant material.
- Limit line length to fewer than 65 characters and end a line with a carriage return.
- Mail should have a subject heading which reflects the content of the message.
- If you include a signature keep it short. Rule of thumb is no longer than 4 lines. Remember that many people pay for connectivity by the minute, and the longer your message is, the more they pay.
- Just as mail (today) may not be private, mail (and news) are (today) subject to forgery and spoofing of various degrees of detectability. Apply common sense "reality checks" before assuming a message is valid.
- If you think the importance of a message justifies it, immediately reply briefly to an e-mail message to let the sender know you got it, even if you will send a longer reply later.

- "Reasonable" expectations for conduct via e-mail depend on your relationship to a person and the context of the communication. Norms learned in a particular e-mail environment may not apply in general to your e-mail communication with people across the Internet. Be careful with slang or local acronyms.
- The cost of delivering an e-mail message is, on the average, paid about equally by the sender and the recipient (or their organizations). This is unlike other media such as physical mail, telephone, TV, or radio. Sending someone mail may also cost them in other specific ways like network bandwidth, disk space or CPU usage. This is a fundamental economic reason why unsolicited e-mail advertising is unwelcome (and is forbidden in many contexts).
- Know how large a message you are sending. Including large files such as Postscript files or programs may make your message so large that it cannot be delivered or at least consumes excessive resources. A good rule of thumb would be not to send a file larger than 50 Kilobytes. Consider file transfer as an alternative, or cutting the file into smaller chunks and sending each as a separate message.
- Don't send large amounts of unsolicited information to people.
- If your mail system allows you to forward mail, beware the dreaded forwarding loop. Be sure you haven't set up forwarding on several hosts so that a message sent to you gets into an endless loop from one computer to the next to the next.

2.1.2 For talk:

Talk is a set of protocols which allow two people to have an interactive dialogue via computer.

- Use mixed case and proper punctuation, as though you were typing a letter or sending mail.
- Don't run off the end of a line and simply let the terminal wrap; use a Carriage Return (CR) at the end of the line. Also, don't assume your screen size is the same as everyone else's. A good rule of thumb is to write out no more than 70 characters, and no more than 12 lines (since you're using a split screen).
- Leave some margin; don't write to the edge of the screen.
- Use two CRs to indicate that you are done and the other person may start typing. (blank line).
- Always say goodbye, or some other farewell, and wait to see a farewell from the other person before killing the session. This is especially important when you are communicating with someone a long way away. Remember that your communication relies on both bandwidth (the size of the pipe) and latency (the speed of light).
- Remember that talk is an interruption to the other person. Only use as appropriate. And never talk to strangers.
- The reasons for not getting a reply are many. Don't assume that everything is working correctly. Not all versions of talk are compatible.
- If left on its own, talk re-rings the recipient. Let it ring one or two times, then kill it.

- If a person doesn't respond you might try another tty. Use finger to determine which are open. If the person still doesn't respond, do not continue to send.
- Talk shows your typing ability. If you type slowly and make mistakes when typing it is often not worth the time of trying to correct, as the other person can usually see what you meant.
- Be careful if you have more than one talk session going!

2.2 Administrator Issues

- Be sure you have established written guidelines for dealing with situations especially illegal, improper, or forged traffic.
- Handle requests in a timely fashion - by the next business day.
- Respond promptly to people who have concerns about receiving improper or illegal messages. Requests concerning chain letters should be handled immediately.
- Explain any system rules, such as disk quotas, to your users. Make sure they understand implications of requesting files by mail such as: Filling up disks; running up phone bills, delaying mail, etc.
- Make sure you have "Postmaster" aliased. Make sure you have "Root" aliased. Make sure someone reads that mail.
- Investigate complaints about your users with an open mind. Remember that addresses may be forged and spoofed.

3.0 One-to-Many Communication Mailing Lists, NetNews

Any time you engage in One-to-Many communications, all the rules for mail should also apply. After all, communicating with many people via one mail message or post is quite analogous to communicating with one person with the exception of possibly offending a great many more people than in one-to-one communication. Therefore, it's quite important to know as much as you can about the audience of your message.

3.1 User Guidelines

3.1.1 General Guidelines for mailing lists and NetNews

- Read both mailing lists and newsgroups for one to two months before you post anything. This helps you to get an understanding of the culture of the group.
- Do not blame the system administrator for the behavior of the system users.
- Consider that a large audience will see your posts. That may include your present or your next boss. Take care in what you write. Remember too, that mailing lists and Newsgroups are frequently archived, and that your words may be stored for a very long time in a place to which many people have access.
- Assume that individuals speak for themselves, and what they say does not represent their organization (unless stated explicitly).
- Remember that both mail and news take system resources. Pay attention to any specific rules

covering their uses your organization may have.

- Messages and articles should be brief and to the point. Don't wander off-topic, don't ramble and don't send mail or post messages solely to point out other people's errors in typing or spelling. These, more than any other behavior, mark you as an immature beginner.
- Subject lines should follow the conventions of the group.
- Forgeries and spoofing are not approved behavior.
- Advertising is welcomed on some lists and Newsgroups, and abhorred on others! This is another example of knowing your audience before you post. Unsolicited advertising which is completely off-topic will most certainly guarantee that you get a lot of hate mail.
- If you are sending a reply to a message or a posting be sure you summarize the original at the top of the message, or include just enough text of the original to give a context. This will make sure readers understand when they start to read your response. Since NetNews, especially, is proliferated by distributing the postings from one host to another, it is possible to see a response to a message before seeing the original. Giving context helps everyone. But do not include the entire original!
- Again, be sure to have a signature which you attach to your message. This will guarantee that any peculiarities of mailers or newsreaders which strip header information will not delete the only reference in the message of how people may reach you.
- Be careful when you reply to messages or postings. Frequently replies are sent back to the address which originated the post - which in many cases is the address of a list or group! You may accidentally send a personal response to a great many people, embarrassing all involved. It's best to type in the address instead of relying on "reply."
- Delivery receipts, non-delivery notices, and vacation programs are neither totally standardized nor totally reliable across the range of systems connected to Internet mail. They are invasive when sent to mailing lists, and some people consider delivery receipts an invasion of privacy. In short, do not use them.
- If you find a personal message has gone to a list or group, send an apology to the person and to the group.
- If you should find yourself in a disagreement with one person, make your responses to each other via mail rather than continue to send messages to the list or the group. If you are debating a point on which the group might have some interest, you may summarize for them later.
- Don't get involved in flame wars. Neither post nor respond to incendiary material.
- Avoid sending messages or posting articles which are no more than gratuitous replies to replies.
- Be careful with monospacing fonts and diagrams. These will display differently on different systems, and with different mailers on the same system.
- There are Newsgroups and Mailing Lists which discuss topics of wide varieties of interests. These represent a diversity of lifestyles, religions, and cultures. Posting articles or sending messages to a

group whose point of view is offensive to you simply to tell them they are offensive is not acceptable. Sexually and racially harassing messages may also have legal implications. There is software available to filter items you might find objectionable.

3.1.2 Mailing List Guidelines

There are several ways to find information about what mailing lists exist on the Internet and how to join them. Make sure you understand your organization's policy about joining these lists and posting to them. In general it is always better to check local resources first before trying to find information via the Internet. Nevertheless, there are a set of files posted periodically to news.answers which list the Internet mailing lists and how to subscribe to them. This is an invaluable resource for finding lists on any topic. See also references [9,13,15] in the Selected Bibliography.

- Send subscribe and unsubscribe messages to the appropriate address. Although some mailing list software is smart enough to catch these, not all can ferret these out. It is your responsibility to learn how the lists work, and to send the correct mail to the correct place. Although many many mailing lists adhere to the convention of having a "-request" alias for sending subscribe and unsubscribe messages, not all do. Be sure you know the conventions used by the lists to which you subscribe.
- Save the subscription messages for any lists you join. These usually tell you how to unsubscribe as well.
- In general, it's not possible to retrieve messages once you have sent them. Even your system administrator will not be able to get a message back once you have sent it. This means you must make sure you really want the message to go as you have written it.
- The auto-reply feature of many mailers is useful for in-house communication, but quite annoying when sent to entire mailing lists. Examine "Reply-To" addresses when replying to messages from lists. Most auto-replies will go to all members of the list.
- Don't send large files to mailing lists when Uniform Resource Locators (URLs) or pointers to ftp-able versions will do. If you want to send it as multiple files, be sure to follow the culture of the group. If you don't know what that is, ask.
- Consider unsubscribing or setting a "nomail" option (when it's available) when you cannot check your mail for an extended period.
- When sending a message to more than one mailing list, especially if the lists are closely related, apologize for cross-posting.
- If you ask a question, be sure to post a summary. When doing so, truly summarize rather than send a cumulation of the messages you receive.
- Some mailing lists are private. Do not send mail to these lists uninvited. Do not report mail from these lists to a wider audience.
- If you are caught in an argument, keep the discussion focused on issues rather than the personalities involved.

3.1.3 NetNews Guidelines

NetNews is a globally distributed system which allows people to communicate on topics of specific

interest. It is divided into hierarchies, with the major divisions being: sci - science related discussions; comp - computer related discussions; news - for discussions which center around NetNews itself; rec - recreational activities; soc - social issues; talk - long-winded never-ending discussions; biz - business related postings; and alt - the alternate hierarchy. Alt is so named because creating an alt group does not go through the same process as creating a group in the other parts of the hierarchy. There are also regional hierarchies, hierarchies which are widely distributed such as Bionet, and your place of business may have its own groups as well. Recently, a "humanities" hierarchy was added, and as time goes on its likely more will be added. For longer discussions on News see references [2,8,22,23] in the Selected Bibliography.

- In NetNews parlance, "Posting" refers to posting a new article to a group, or responding to a post someone else has posted. "Cross-Posting" refers to posting a message to more than one group. If you introduce Cross-Posting to a group, or if you direct "Followup-To:" in the header of your posting, warn readers! Readers will usually assume that the message was posted to a specific group and that followups will go to that group. Headers change this behavior.
- Read all of a discussion in progress (we call this a thread) before posting replies. Avoid posting "Me Too" messages, where content is limited to agreement with previous posts. Content of a follow-up post should exceed quoted content.
- Send mail when an answer to a question is for one person only. Remember that News has global distribution and the whole world probably is NOT interested in a personal response. However, don't hesitate to post when something will be of general interest to the Newsgroup participants.
- Check the "Distribution" section of the header, but don't depend on it. Due to the complex method by which News is delivered, Distribution headers are unreliable. But, if you are posting something which will be of interest to a limited number of readers, use a distribution line that attempts to limit the distribution of your article to those people. For example, set the Distribution to be "nj" if you are posting an article that will be of interest only to New Jersey readers.
- If you feel an article will be of interest to more than one Newsgroup, be sure to CROSSPOST the article rather than individually post it to those groups. In general, probably only five-to-six groups will have similar enough interests to warrant this.
- Consider using Reference sources (Computer Manuals, Newspapers, help files) before posting a question. Asking a Newsgroup where answers are readily available elsewhere generates grumpy "RTFM" (read the fine manual - although a more vulgar meaning of the word beginning with "f" is usually implied) messages.
- Although there are Newsgroups which welcome advertising, in general it is considered nothing less than criminal to advertise off-topic products. Sending an advertisement to each and every group will pretty much guarantee your loss of connectivity.
- If you discover an error in your post, cancel it as soon as possible.
- DO NOT attempt to cancel any articles but your own. Contact your administrator if you don't know how to cancel your post, or if some other post, such as a chain letter, needs canceling.
- If you've posted something and don't see it immediately, don't assume it's failed and re-post it.

- Some groups permit (and some welcome) posts which in other circumstances would be considered to be in questionable taste. Still, there is no guarantee that all people reading the group will appreciate the material as much as you do. Use the Rotate utility (which rotates all the characters in your post by 13 positions in the alphabet) to avoid giving offense. The Rot13 utility for Unix is an example.
- In groups which discuss movies or books it is considered essential to mark posts which disclose significant content as "Spoilers". Put this word in your Subject: line. You may add blank lines to the beginning of your post to keep content out of sight, or you may Rotate it.
- Forging of news articles is generally censured. You can protect yourself from forgeries by using software which generates a manipulation detection "fingerprint", such as PGP (in the US).
- Postings via anonymous servers are accepted in some Newsgroups and disliked in others. Material which is inappropriate when posted under one's own name is still inappropriate when posted anonymously.
- Expect a slight delay in seeing your post when posting to a moderated group. The moderator may change your subject line to have your post conform to a particular thread.
- Don't get involved in flame wars. Neither post nor respond to incendiary material.

3.2 Administrator Guidelines

3.2.1 General Issues

- Clarify any policies your site has regarding its subscription to NetNews groups and about subscribing to mailing lists.
- Clarify any policies your site has about posting to NetNews groups or to mailing lists, including use of disclaimers in .sigs.
- Clarify and publicize archive policy. (How long are articles kept?)
- Investigate accusations about your users promptly and with an open mind.
- Be sure to monitor the health of your system.
- Consider how long to archive system logs, and publicize your policy on logging.

3.2.2 Mailing Lists

- Keep mailing lists up to date to avoid the "bouncing mail" problem.
- Help list owners when problems arise.
- Inform list owners of any maintenance windows or planned downtime.
- Be sure to have "-request" aliases for list subscription and administration.
- Make sure all mail gateways operate smoothly.

3.2.3 NetNews

- Publicize the nature of the feed you receive. If you do not get a full feed, people may want to know

why not.

- Be aware that the multiplicity of News Reader clients may cause the News Server being blamed for problems in the clients.
- Honor requests from users immediately if they request cancellation of their own posts or invalid posts, such as chain letters.
- Have "Usenet", "Netnews" and "News" aliased and make sure someone reads the mail.

3.3 Moderator Guidelines

3.3.1 General Guidelines

- Make sure your Frequently Asked Questions (FAQ) is posted at regular intervals. Include your guidelines for articles/messages. If you are not the FAQ maintainer, make sure they do so.
- Make sure you maintain a good welcome message, which contains subscribe and unsubscribe information.
- Newsgroups should have their charter/guidelines posted regularly.
- Keep mailing lists and Newsgroups up to date. Post messages in a timely fashion. Designate a substitute when you go on vacation or out of town.

4.0 Information Services

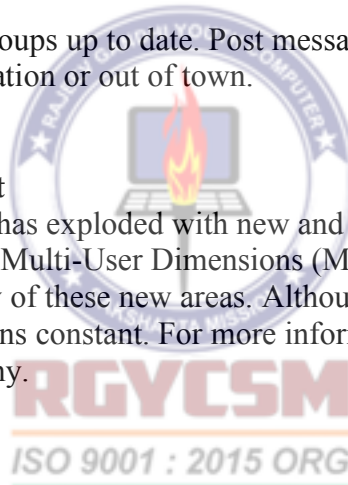
Gopher, Wais, WWW, ftp, telnet

In recent Internet history, the 'Net has exploded with new and varied Information services. Gopher, Wais, World Wide Web (WWW), Multi-User Dimensions (MUDs) Multi-User Dimensions which are Object Oriented (MOOs) are a few of these new areas. Although the ability to find information is exploding, "Caveat Emptor" remains constant. For more information on these services, check references [14,28] in the Selected Bibliography.

4.1 User Guidelines

4.1.1. General guidelines

- Remember that all these services belong to someone else. The people who pay the bills get to make the rules governing usage. Information may be free - or it may not be! Be sure you check.
- If you have problems with any form of information service, start problem solving by checking locally: Check file configurations, software setup, network connections, etc. Do this before assuming the problem is at the provider's end and/or is the provider's fault.
- Although there are naming conventions for file-types used, don't depend on these file naming conventions to be enforced. For example, a ".doc" file is not always a Word file.
- Information services also use conventions, such as www.xyz.com. While it is useful to know these conventions, again, don't necessarily rely on them.
- Know how file names work on your own system.
- Be aware of conventions used for providing information during sessions. FTP sites usually have files named README in a top level directory which have information about the files available. But, don't



assume that these files are necessarily up-to-date and/or accurate.

- Do NOT assume that ANY information you find is up-to-date and/or accurate. Remember that new technologies allow just about anyone to be a publisher, but not all people have discovered the responsibilities which accompany publishing.
- Remember that unless you are sure that security and authentication technology is in use, that any information you submit to a system is being transmitted over the Internet "in the clear", with no protection from "sniffers" or forgers.
- Since the Internet spans the globe, remember that Information Services might reflect culture and life-style markedly different from your own community. Materials you find offensive may originate in a geography which finds them acceptable. Keep an open mind.
- When wanting information from a popular server, be sure to use a mirror server that's close if a list is provided.
- Do not use someone else's FTP site to deposit materials you wish other people to pick up. This is called "dumping" and is not generally acceptable behavior.
- When you have trouble with a site and ask for help, be sure to provide as much information as possible in order to help debug the problem.
- When bringing up your own information service, such as a homepage, be sure to check with your local system administrator to find what the local guidelines are in affect.
- Consider spreading out the system load on popular sites by avoiding "rush hour" and logging in during off-peak times.

4.1.2 Real Time Interactive Services Guidelines (MUDs MOOs IRC)

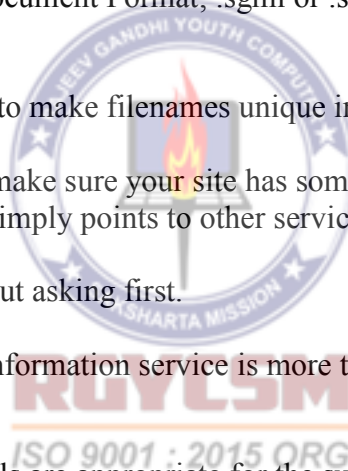
- As in other environments, it is wise to "listen" first to get to know the culture of the group.
- It's not necessary to greet everyone on a channel or room personally. Usually one "Hello" or the equivalent is enough. Using the automation features of your client to greet people is not acceptable behavior.
- Warn the participants if you intend to ship large quantities of information. If all consent to receiving it, you may send, but sending unwanted information without a warning is considered bad form just as it is in mail.
- Don't assume that people who you don't know will want to talk to you. If you feel compelled to send private messages to people you don't know, then be willing to accept gracefully the fact that they might be busy or simply not want to chat with you.
- Respect the guidelines of the group. Look for introductory materials for the group. These may be on a related ftp site.
- Don't badger other users for personal information such as sex, age, or location. After you have built an acquaintance with another user, these questions may be more appropriate, but many people hesitate to give this information to people with whom they are not familiar.

- If a user is using a nickname alias or pseudonym, respect that user's desire for anonymity. Even if you and that person are close friends, it is more courteous to use his nickname. Do not use that person's real name online without permission.

4.2 Administrator Guidelines

4.2.1 General Guidelines

- Make clear what's available for copying and what is not.
- Describe what's available on your site, and your organization. Be sure any general policies are clear.
- Keep information, especially READMEs, up-to-date. Provide READMEs in plain ascii text.
- Present a list of mirrors of your site if you know them. Make sure you include a statement of copyright applicable to your mirrors. List their update schedule if possible.
- Make sure that popular (and massive) information has the bandwidth to support it.
- Use conventions for file extensions - .txt for ascii text; .html or .htm for HTML; .ps for Postscript; .pdf for Portable Document Format; .sgml or .sgm for SGML; .exe for non-Unix executables, etc.
- For files being transferred, try to make filenames unique in the first eight characters.
- When providing information, make sure your site has something unique to offer. Avoid bringing up an information service which simply points to other services on the Internet.
- Don't point to other sites without asking first.
- Remember that setting up an information service is more than just design and implementation. It's also maintenance.
- Make sure your posted materials are appropriate for the supporting organization.
- Test applications with a variety of tools. Don't assume everything works if you've tested with only one client. Also, assume the low end of technology for clients and don't create applications which can only be used by Graphical User Interfaces.
- Have a consistent view of your information. Make sure the look and feel stays the same throughout your applications.
- Be sensitive to the longevity of your information. Be sure to date time-sensitive materials, and be vigilant about keeping this information well maintained.
- Export restrictions vary from country to country. Be sure you understand the implications of export restrictions when you post.
- Tell users what you plan to do with any information you collect, such as WWW feedback. You need to warn people if you plan to publish any of their statements, even passively by just making it available to other users.



- Make sure your policy on user information services, such as homepages, is well known.

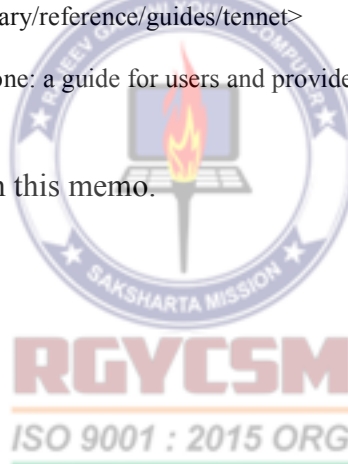

Top Five Signs That a Message is a Hoax

The next time that you receive an alarming e-mail calling you to action, look for one or more of these five telltale characteristics before even thinking about sending it along to anybody else.

1. URGENT

The e-mail will have a great sense of urgency! You'll usually see a lot of exclamation points and capitalization. The subject line will typically be something like:

URGENT!!!!!!
WARNING!!!!!!
IMPORTANT!!!!!!
VIRUS ALERT!!!!!!

2. TELL ALL YOUR FRIENDS

There will always be a request that you share this "important" warning by forwarding the message to everybody in your e-mail address book or to as many people as you possibly can. This is a surefire sign that the message is a hoax.

3. THIS ISN'T A HOAX

The body of the e-mail will contain some form of corroboration, such as a pseudo-quote from an executive of a major corporation or from a government agency official.

Sometimes the message will include a sincere-sounding premise. For example:

My neighbor, who works for Microsoft, just received this warning so I know it's true. He asked me to pass this along to as many people as I can.

It's all a bunch of baloney. Don't believe it for a second.

Watch for e-mails containing a subtle form of self-corroboration. Statements such as "This is serious!" or "This is not a hoax!" can be deceiving. Just because somebody says it's not a hoax doesn't make it so.

4. DIRE CONSEQUENCES

The e-mail text will predict dire (but impossible) consequences if you don't act immediately. The message may inform you that the virus will destroy your hard drive, kill your houseplants, or cause green fuzzy things to grow in your refrigerator.

5. HISTORY

Look for a lot of >>>> marks in the left margin. These marks indicate that people suckered by the hoax have forwarded the message countless times before it has reached you.

NOTE: It is possible that you may receive a virus hoax e-mail with an attached file. Such file attachments should be treated with caution, and we recommend practicing SAFE COMPUTING.

Now It's Time to Play **Spot the Hoax:**

The following are actual virus hoax e-mails. Thousands of people have forwarded the "Budweiser Frogs" and "Virtual Card for You" hoaxes to millions of Internet users, keeping them in circulation for years. See how many of the five hoax signs you can spot!

>>>>Subject: READ IMMEDIATELY AND PASS ON!

>>>Someone is sending out a very cute screensaver of the Budweiser
>>>Frogs. If you download it, you will lose everything! Your hard drive
>>>will crash and someone from the Internet will get your screen name

>>>It just went into circulation yesterday. Please distribute this

Safe Computing

In the early days of computing, the main delivery source for malicious programs (viruses, worms, Trojan horses) was via file sharing – passing files around on disk or diskette. These days, e-mail is the vehicle of choice because this is the weakest link in the computer security chain. Infected programs are easily passed along as attachments to an e-mail message, and a simple click of the mouse is all that is required to start a devastating chain reaction, sometimes resulting in the complete destruction of all data stored on a hard drive.

These types of programs are known as executable programs. One has to actually cause the program to run to activate the malicious code within the program. You could compare this to running a copy of Word, or Quicken, or any other type of program that produces some kind of result. Typically, these executable programs end with the file extension of **.exe**, **.com**, **.bat**, **.pif**, **.vbs** and **.scr** (screensaver).

Virus writers take advantage of security flaws that are built right into these mail programs to deposit their evil little "worms." Most of these worms work the same way: it first infects your computer, then, exploiting the "flaws" within Outlook or Outlook Express, sends itself to everyone in your e-mail address book. Because all of this happens automatically, without the knowledge of the infected user, the infected file that you received will have appeared to have been sent to you specifically by your friend. It will appear to be a file that they really wanted you to have. You then activate the virus in your system by double clicking on the file, and the process begins all over again, with the infected file being sent from your computer, and so on, and so on, and so on. Now, because of certain Microsoft programming flaws, it is possible to become infected merely by looking at the message in the preview pane of Outlook or Outlook Express, with no further action required by the user.

There are literally thousands of computer viruses. Fortunately, most of these are not in circulation. In the parlance of the trade, these are known as being *in the zoo*. But when they are out on the Internet, being circulated in e-mail, they are known as being *in the wild*. Most of the viruses seen these days are actually worms. Generally, a worm will find its way into the user's address book and send a copy of itself to everyone in the address book. Remember the Melissa Virus? It was sending so many copies of itself that it literally shut down some big commercial systems. Some of the worms making the rounds these days are Pretty Park, Happy 99, My Pics, Fremlink and Bubble Boy. Some of these worms are benign in nature, such as making a message pop up on a monitor screen. But some, like the recent *Naked Wife* virus, are **very destructive**, able to wipe out selected files, or an entire hard drive. Viruses are able to hide in files, in computer memory, or in the boot sector of a hard drive.

So what can one do to protect against contracting a computer virus? Practice safe computing! First and foremost, use an antivirus program. And for goodness sake, update the virus data file on a regular basis (daily, if possible). **Always** check programs downloaded from the Web with an antivirus program. **Always** check software borrowed from a friend (even if they say that it's virus free). **Never** open an executable program received via e-mail (this last piece of advice may upset some folks), even from someone that is known (the program could still be infected without the sender's knowledge). Finally, if using Microsoft products for browsing and/or e-mail, download the latest security updates directly from the Microsoft website.

Here is how to practice safe computing:

NEVER, NEVER, NEVER, NEVER, NEVER, NEVER, NEVER OPEN
ATTACHED EXECUTABLE FILES SENT TO YOU VIA E-MAIL!!!!!!

Don't have antivirus software (shame on you)? The creators of PC-cillin, Trend Micro, offers a [free web-based virus scan](#) for your computer.

How to perform Security Updates

The following steps assume that you have previously installed the indicated programs.

A. Anti-Virus

1. Right-Click on the AVG Icon on the Taskbar (right end),
2. Select **Check for Updates**,
3. If there are no updates available, go to section B below.
4. If updates are available, select the highest priority update, download, and install it,
5. Go back to step 1 above.

B. Anti-Spyware

1. Select Spybot from the Taskbar (left end) or from the program list,
2. Click on the **Search for Update** button [use Safer-Networking #2 - Europe] and **Continue**,
3. Select all download options and Download,
4. Exit the Updater window and click on the Immunize Icon on the left,
5. Once Spybot has recognized everything that needs to be immunized, click on the Immunize Button with the green plus sign. (all unprotected = 0)
6. If desired, activate the Search & Destroy option,
7. Check for problems.



Printers, the Underlying Business Model

A common business model for inkjet printers involves selling the actual printer at or below production cost, while dramatically marking up the price of the (proprietary) ink cartridges. Some inkjet printers enforce this tying together of products using microchips in the cartridges to prevent the use of third-party or refilled ink cartridges. The microchips can function by storing an amount of ink remaining in the cartridge, which is updated as printing is conducted. Expiration dates for the ink may also be used. Even if the cartridge is refilled, the microchip will indicate to the printer that the cartridge is depleted. For some printers, special circuit flashers are available that reset the quantity of remaining ink to the maximum. Some manufacturers have been accused of indicating that a cartridge is depleted while a substantial amount of ink remains in the cartridge.

Alternatives for consumers are cheaper copies of cartridges, produced by other companies, and refilling cartridges, for which refill kits are available. Owing to the large differences in pricing due to OEM markups, there are many companies specializing in these alternative ink cartridges. Most printer manufacturers discourage refilling disposable cartridges or using aftermarket copy cartridges. Refilling cartridges causes the manufacturers to lose revenue. Using non-qualified inks can cause poor image quality due to differences in viscosity, which can affect the amount of ink ejected in a drop, and color consistency. Refilling can also damage the printhead.

Overview of Resolution

Analog television systems use interlace scanning with two sequential scans (50 or 60 fields per second), one with the odd numbered lines, the other with the even numbered lines to give a complete picture (25 or 30 frames per second). This is done to save transmission bandwidth but a consequence is that in picture tube (CRT) displays, the full vertical resolution cannot be realized. For example, the maximum detail in the vertical direction would be for adjacent lines to be alternately black then white. This is not a problem in a progressive display but an interlace display will have an unacceptable flicker or twitter at the slower frame rate. This is why interlace is unacceptable for fine detail such as computer word processing or spreadsheets. For television it means that if the picture is intended for interlace displays the picture must be vertically filtered to remove this objectionable flicker with a reduction of vertical resolution. According to the Kell factor the reduction is to about 85%, so a 576 line PAL interlace display only has about 480 lines vertical resolution, and a 486 line NTSC interlace display has a resolution of approximately 410 lines vertical. Similarly, 1080i digital interlaced video would need to be filtered to about 910 lines for an interlaced display, although a fixed pixel display (such as LCD) eliminates the inaccuracies of scanning, and thus can achieve Kell factors as high as 95% or 1020 lines.

Fixed pixel array displays such as LCDs, plasmas, etc. need a "scaling" processor with frame memory, which, depending on the processing system, effectively converts an incoming interlaced picture into progressive. A similar process occurs in a PC and its display with interlaced video (e.g., from a TV tuner card). The downside is that interlace motion artifacts are almost impossible to remove resulting in horizontal "toothed" edges on moving objects.

Also in analog connected picture displays such as CRT TV sets, the horizontal scanlines are not divided into pixels, and therefore the horizontal resolution is related to the bandwidth of the luminance and chroma signals. For television, the analog bandwidth for luminance in standard definition can vary from 3 MHz (approximately 330 lines edge-to-edge; VHS) to 4.2 MHz (440 lines; live analog tv) up to 7 MHz (660 lines; DVD). In high definition the bandwidth is 37 MHz (720p/1080i) or 74 MHz (1080p/60).

Current Standards

SDTV: 576i (PAL, 720×576 split into two 288-line fields)

EDTV: 480p (NTSC, 720×480)

HDTV: 720p (1280×720)

HDTV: 1080i (1280×1080, 1440×1080, or 1920×1080 split into two 540-line fields)

HDTV: 1080p (1920*1080 progressive scan)

Computers have higher resolutions:

Currently, 1024×768 Extended Graphics Array is the most common display resolution. Many web sites and multimedia products were re-designed from the previous 800×600 format to the higher 1024×768-optimized layout.

The availability of inexpensive LCD monitors has made the 5:4 aspect ratio resolution of 1280×1024 more popular for desktop usage. Many computer users including CAD users, graphic artists and video game players run their computers at 1600×1200 resolution (UXGA, Ultra-eXtended) or higher if they have the necessary equipment. Other recently available resolutions include oversize aspects like 1400×1050 SXGA+ and wide aspects like 1280×720 WXGA, 1680×1050 WSXGA+, and 1920×1200 WUXGA.

The most common computer display resolutions are as follows:

When a computer display resolution is set higher than the physical screen resolution, some video drivers make the virtual screen scrollable over the physical screen. Most LCD manufacturers do make note of the fact that the panel's native resolution as working in a non-native resolution on LCDs will result in a poorer image. This is due to dropping of pixels to make the image fit (when using DVI) or insufficient sampling of the analog signal (when using VGA connector). Few CRT manufacturers will quote the true native resolution since CRTs are analog in nature and can vary their display from as low as 320×200 (emulation of older computers or game consoles) to as high as the internal board will allow, or the image becomes too detailed for the vacuum tube to recreate (i.e. analog blur). Thus CRTs provide a variability in resolution that LCDs cannot provide (LCDs have fixed resolution).



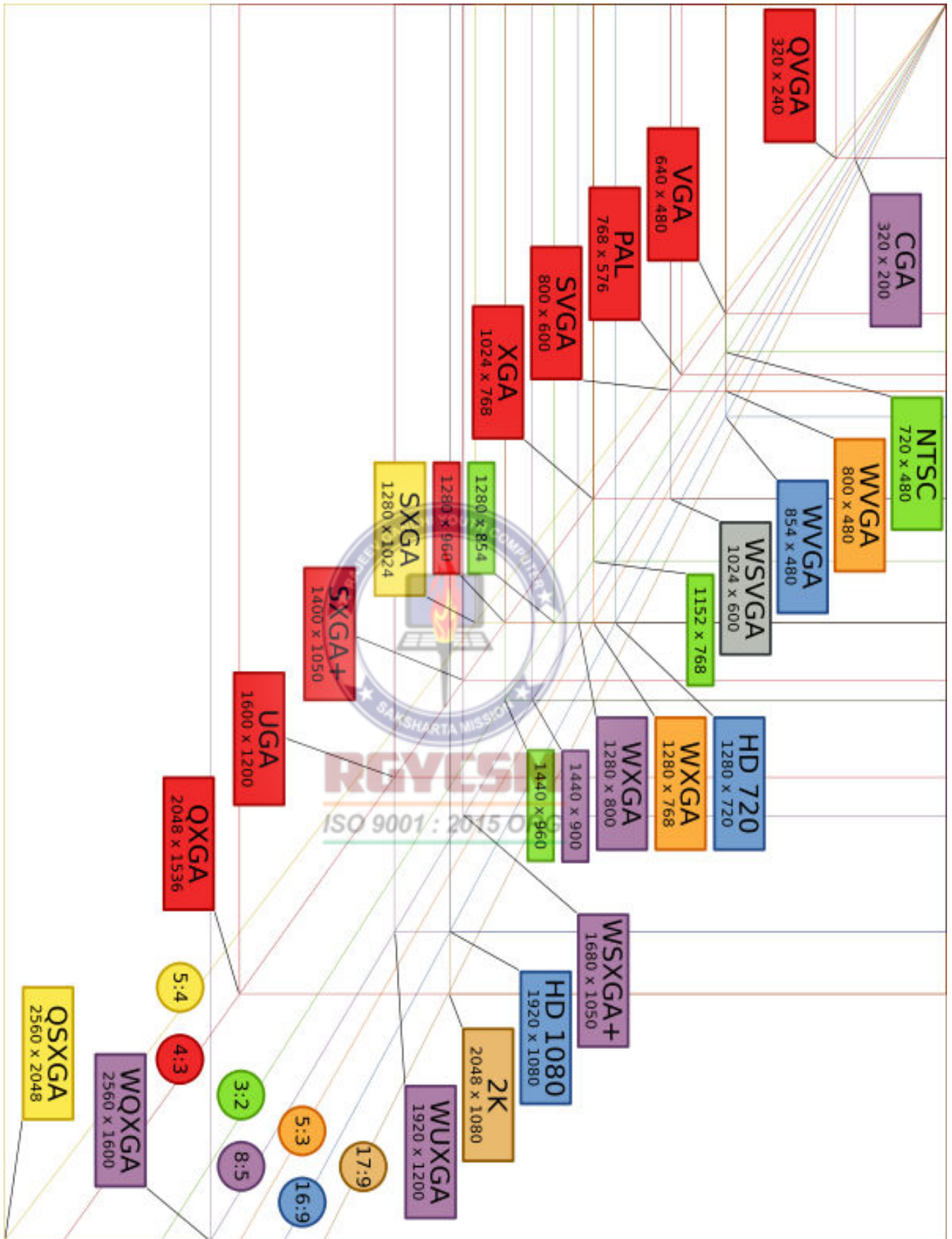


Illustration 43: Video Standards

More about Pixels

The measures dots per inch (dpi) and pixels per inch (ppi) are sometimes used interchangeably, but have distinct meanings especially in the printer field, where dpi is a measure of the printer's resolution of dot printing (e.g. ink droplet density). For example, a high-quality inkjet image may be printed with 200 ppi on a 720 dpi printer.

The more pixels used to represent an image, the closer the result can resemble the original. The number of pixels in an image is sometimes called the resolution, though resolution has a more specific definition. Pixel counts can be expressed as a single number, as in a "three-megapixel" digital camera, which has a nominal three million pixels, or as a pair of numbers, as in a "640 by 480 display", which has 640 pixels from side to side and 480 from top to bottom (as in a VGA display), and therefore has a total number of $640 \times 480 = 307,200$ pixels or 0.3 megapixels.

The pixels, or color samples, that form a digitized image (such as a JPEG file used on a web page) may or may not be in one-to-one correspondence with screen pixels, depending on how a computer displays an image.

In computing, an image composed of pixels is known as a bitmapped image or a raster image. The word raster originates from television scanning patterns, and has been widely used to describe similar half-tone printing and storage techniques.

Display resolution vs. native resolution in computer monitors

Computers can use pixels to display an image, often an abstract image that represents a GUI (Graphical User Interface). The resolution of this image is called the display resolution and is determined by the video card of the computer.

Modern computer monitors also use pixels to display an image, and have a native resolution. In the case of an LCD monitor, each pixel is made up of triads, with the number of these triads determining the native resolution. On some CRT monitors, the beam sweep rate may be fixed, resulting in a fixed native resolution.

To produce the sharpest images possible, the user must ensure the display resolution of the computer matches the native resolution of the monitor.

If these resolutions are different, the image may appear squashed or stretched, or the monitor may resample the image, resulting in a blurry or jagged appearance.

Bits per pixel

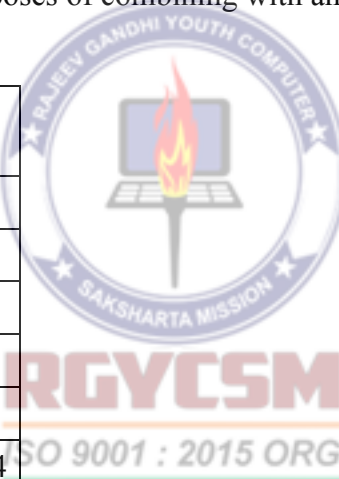
The number of distinct colors that can be represented by a pixel depends on the number of bits per pixel (bpp). A 1 bpp image uses 1 bit for each pixel, so each pixel can be either on or off. Each additional bit doubles the number of colors available, so a 2 bpp image can have 4 colors, and a 3 bpp image can have 8 colors:

- 1 bpp, $2^1 = 2$ colors (monochrome)
- 2 bpp, $2^2 = 4$ colors
- 3 bpp, $2^3 = 8$ colors
- ...
- 8 bpp, $2^8 = 256$ colors
- 16 bpp, $2^{16} = 65,536$ colors ("Highcolor")
- 24 bpp, $2^{24} \approx 16.7$ million colors ("Truecolor")

For color depths of 15 or more bits per pixel, the depth is normally the sum of the bits allocated to each of the red, green, and blue components. Highcolor, usually meaning 16 bpp, normally has five bits for red and blue, and six bits for green, as the human eye is more sensitive to errors in green than in the other two primary colors. For applications involving transparency, the 16 bits may be divided into five bits each of red, green, and blue, with one bit left for transparency. A 24-bit depth allows 8 bits per component. On some systems, 32-bit depth is available: this means that each 24-bit pixel has an extra 8 bits to describe its opacity (for purposes of combining with another image).

Database Design and Implementation using MS Works

We have the Microsoft Works integrated package licensed in this class, so will be using the Works Database program to design and create an address book database. Please be very careful to follow all instructions exactly when you create your database as we want to make them interchangeable with all others. That means spelling and even capitalization must match from one student's database to another's.

During class, I will be talking you through all the required steps but thought I would provide this document as an addendum so I could save some time in laying out the **database** and to try to normalize the results across all students.

Definitions:

Field – this is a single, discrete piece of information. A last name, a phone number, and a zip code are all fields.

Record – this is all the information about a single, unique entity. In our case, it is all information about a single person in our **addressbook database**. A **record** is composed of **fields** of information.

Database – this has two definitions:

11. The program used to create and maintain records of information, and
12. A group of **records** as defined above. Therefore, we are going to create an AddressBook database using a **database** program. Notice I have combined the word address and book into a single word. This is how we will save the **database**.

Step 1:

In designing a **database** you should always start with pencil and paper. Write down all the **fields** you think you will want and as much information as you think you will need to get the results you want. In our case, we are going to use this **addressbook** later with our exercise in mail merge, so there are certain **fields** we will definitely want to have. I will list each field along with all the information associated with it so we will all be working using the same template. Please make sure you spell the field names exactly as I do or your **database** will not work with someone else's mail merge document.

Step 2:

Run the **database program** and create your **database template** using the data as shown above. I will be going over this in more detail during class.

Step 3:

Populate your **database**. This means you simply add the information you want to store into the **database**. Don't forget to **SAVE OFTEN!** A good time to save would be after entering each **Record** into the **database**. Use the name AddressBook as the name to save under. Please note that both the "A" and the "B" are capitalized and there is no space between "Address" and "Book".

Mail Merge using MS Works

With the Microsoft Works integrated package licensed to this class we will be using the Works Word Processor program to design and create a mail merge document. Please be very careful to follow all instructions exactly when you create your document as we want to make them interchangeable with all others.

Again, I thought I would provide this document as an addendum so I could save some time in laying out the mail merge document and to try to normalize the results across all students. We will be creating a simple business letter with very few fields but it will be enough to show you that much more complex mail merge is possible.

Step 1:

Run the Microsoft Works Word Processor and click on **Tools\Mail Merge\Open Data Source**. You will be presented with two options. You may either Merge from the Address Book (this is associated with your email program) or Merge information from another type of file. The second option is the one we want to use. When you select the second option, an "Open Data Source" window will open. Simply navigate to My Documents\ClassNight and find the AddressBook.wdb file we created last class. Once selected, an "Insert Fields" window will open offering all the fields in the database for insertion into your letter. Use the fields as if they were the actual data you would ordinarily insert into your letter.

Step 2:

The word processing program is already open, so create your mail merge template using the data from the "Insert Fields" window and the copy shown below. I will be going over this in more detail during class. Don't forget to **SAVE OFTEN!** A good time to save would be after entering each paragraph. Use your first name as the name to save under.

Step 3:

Whoever finishes first will have their document used to demonstrate how easy Mail Merge truly is. It would be nice to allow all students to print all letters but we do not have the resources for that. It is easy to do at home though, if you have your own computer.

Here is a sample letter to use when creating your Mail Merge Document:

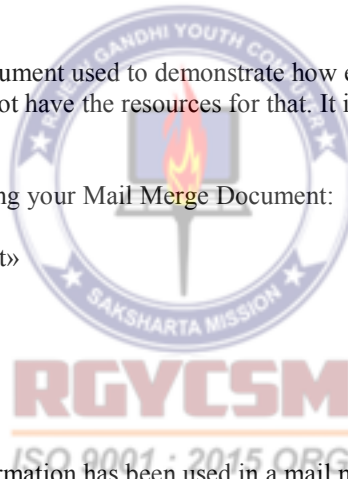

Life 101

Wallets

From a corporate attorney sent this out to the employees in his company:

"WHAT TO DO IF YOU LOSE YOUR PURSE OR WALLET"

We've all heard horror stories about fraud that's committed us in your name, address, SS#, credit, etc. Unfortunately I (the author of this piece who happens to be an attorney) have firsthand knowledge, because my wallet was stolen last month and within a week the thief(s) ordered an expensive monthly cell phone package, applied for a VISA credit card, had a credit line approved to buy Gateway computer, received a PIN number from DMV to change my driving record information online, and more.

But here's some critical information to limit the damage in case this happens to you or someone you know. As everyone always advises, cancel your credit cards immediately, but the key is having the toll free numbers and your card numbers handy so you know whom to call. Keep those where you can find them easily. File a police report immediately in the jurisdiction where it was stolen, this proves to credit providers you were diligent, and is a first step toward an investigation (if there ever is one).

But here's what is perhaps most important: (I never ever thought to do this) - Call the three national credit reporting organizations immediately to place a fraud alert on your name and SS#.

I had never heard of doing that until advised by a bank that called to tell me and application for credit was made over the Internet in my name. The alert means any company that checks your credit knows your information was stolen and they have to contact you by phone to authorize new credit. By the time I was advised to do this, almost 2 weeks after the theft, all the damage had been done.

There are records of all the credit checks initiated by the thieves' purchases, none of which knew about before placing the alert. Since then, no additional damage has been done, and the thieves threw my wallet away this weekend (someone turned it in). It seems to have stopped them in their tracks.

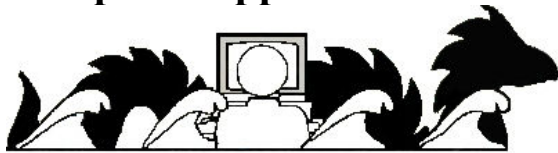
